

2026 Meeting Schedule and Council Deadlines

If your agenda is **not** prepared in Legistar, e-mail your template-based agenda to meetings@cityofmadison.com by noon of the Friday before the meeting takes place. Your Legistar based agenda links will be sent to meetings@cityofmadison.com automatically, but the Friday deadline remains.

- ★ In order to comply with the Wisconsin Open Meetings law, the City Clerk's Office must physically post your agenda on the official bulletin board at least 24 hours before the start of a meeting. By posting the agenda the Friday before a meeting takes place, we provide Madison residents with time to arrange for transportation, childcare, or a language interpreter.
- ★ If an agenda is not posted by the City Clerk's Office on the official bulletin board at least 24 hours in advance, the meeting *cannot be held*.
- ★ Weekends are treated as one overnight time period for posting meetings – e.g. your Monday meeting that starts at 2:30pm must be posted by 2:30pm on the Friday before.

Section 33.01(10) of the Madison General Ordinances **prohibits scheduling meetings** on Election Days and during budget deliberations. Those dates in 2026 will be:

- Tuesday, April 7, 2026 (Spring Election)
- Tuesday, August 11, 2026 (Fall Primary Election)
- Monday, September 14, 2026
(Finance Committee budget deliberations, no meetings after 4:30 p.m.)
- Tuesday, September 15, 2026
(Finance Committee budget deliberations, no meetings after 4:30 p.m.)
- Monday, September 28, 2026
(Finance Committee budget deliberations, no meetings after 4:30 p.m.)
- Monday, October 12, 2026
(Finance Committee budget deliberations, no meetings after 4:30 p.m.)
- Tuesday, October 13, 2026
(Finance Committee budget deliberations, no meetings after 4:30 p.m.)
- Monday, October 26, 2026
(Finance Committee budget deliberations, no meetings after 4:30 p.m.)
- Tuesday, November 3, 2026 (General Election)
- Tuesday, November 10, 2026
(Council budget deliberations, other meetings must **adjourn** by 5:30 p.m.)
- Wednesday, November 11, 2026
(Council budget deliberations, other meetings must **adjourn** by 5:30 p.m.)
- Thursday, November 12, 2026
(Council budget deliberations, other meetings must **adjourn** by 5:30 p.m.)

The Council has also prohibited meetings for themselves and all BCCs for the following holidays:

New Year's Day Thursday, January 1

Martin Luther King Jr. Day Monday, January 19

Good Friday Friday, April 3

***Please note that while the Council does *not* prohibit scheduling meetings on Good Friday, based on past practice we **recommend** that you avoid it.**

Passover (first two and last two days) Sunset Wednesday, April 1, through sunset Thursday, April 2, *and* sunset Wednesday, April 8, through sunset Thursday, April 9

***Please note that the Council only identifies the first two days as *prohibited*. Based on past practice, we also **recommend** that you avoid the last two days of Passover.**

Eid al-Fitr Sunset Thursday, March 19 through sunset Friday, March 20

Memorial Day Monday, May 25

Juneteenth Friday, June 19

Eid al-Adha Sunset Tuesday, May 26 through sunset Wednesday, May 27

Independence Day Saturday, July 4

Rosh Hashanah Sunset Friday, September 11, through sunset Sunday, September 13

Yom Kippur Sunset Sunday, September 20 through sunset Monday, September 21

2026 Legistar Deadlines for Common Council Agenda Items

Add CC Agenda Date

If you have a Legistar file that needs to appear on the next Council agenda, put the date of that Council meeting in the file's "CC Agenda Date" field.

Deadline for Finance Approval Workflow

All resolutions and ordinances must be reviewed by the Finance Department for a fiscal note. In the "Approval Tracking" tab, add your agency's budget analyst from the drop-down list in "Add Sequence" and click "Start." The Finance approval workflow must be started by 8am on the Legistar deadline day. This allows the budget analyst time to review and write fiscal notes before the Clerk's Office generates the agenda at 12pm.

Deadline for Clerk's Office Submittal Form

In addition to creating the file in Legistar with the correct meeting date, you should complete the Common Council submittal form:

The Clerk's Office generates a submittal form report at 12pm noon on the Legistar deadline day, and double checks that each of the files listed on the report has pulled into the agenda. If you complete the submittal form after the noon deadline, the Clerk's Office will not see your submittal.

If your file will not be ready for the agenda by the deadline listed below, contact the Clerk's Office directly at clmeetings@cityofmadison.com and copy your agency's budget analyst.

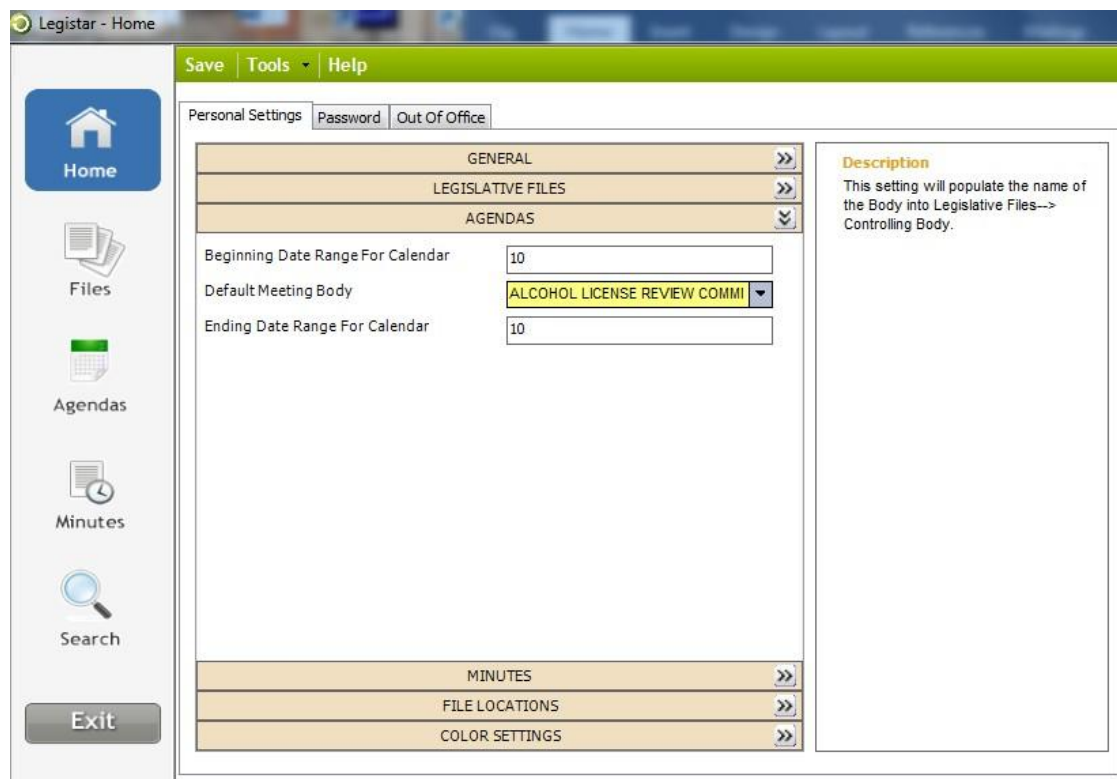

Entering Meeting Dates into Legistar

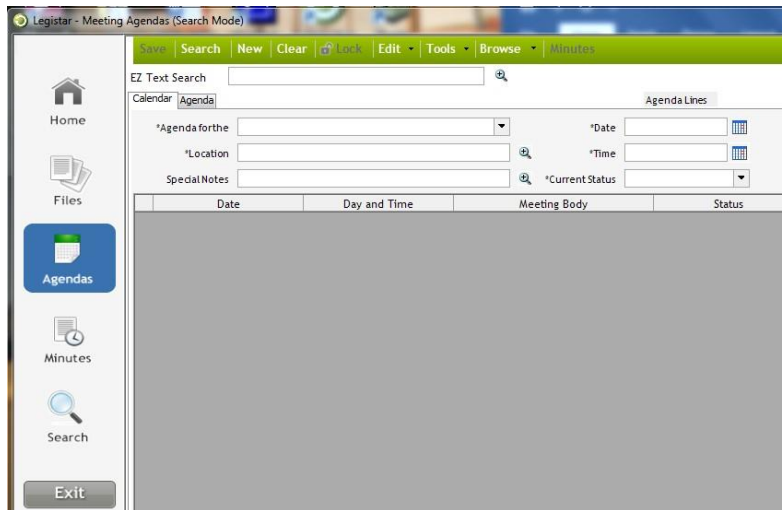
1. Go to Local Settings under Tools at the top of your Legistar home screen.



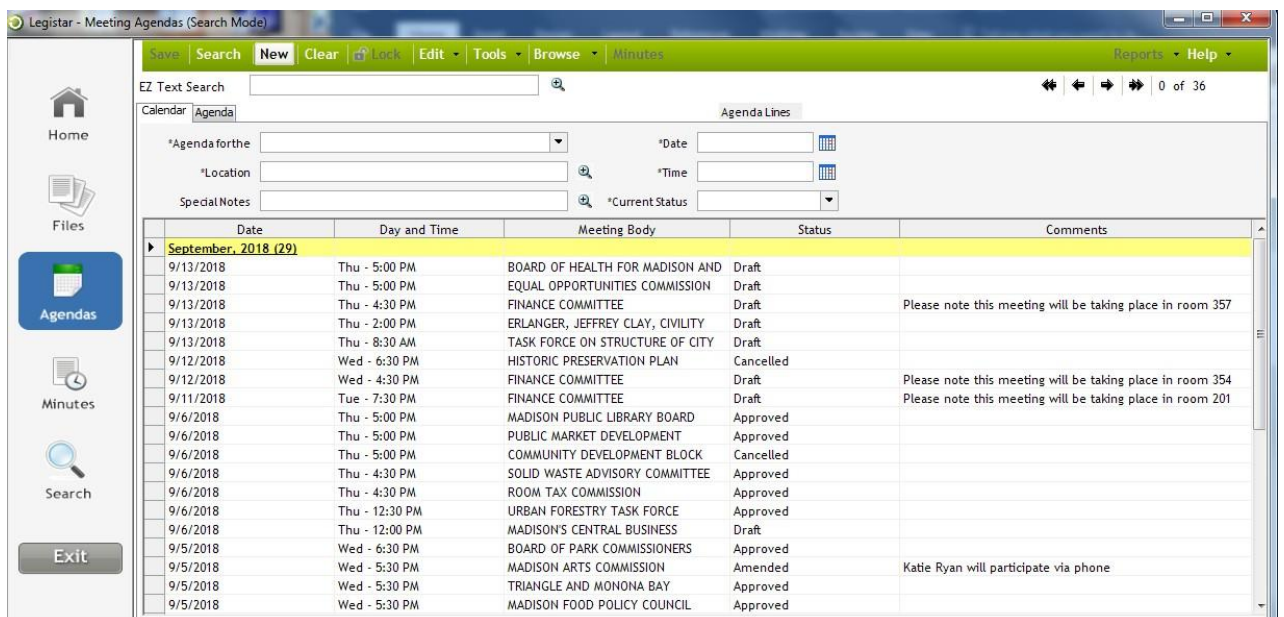
2. Under the Personal Settings tab, expand your options under Agendas and make sure your Default Meeting Body is your committee. If you need to change the Default Meeting Body, select your committee from the drop-down menu and click Save at the top of the screen.



3. Go to Agendas in Legistar.



4. Select New at the top of the screen.



5. Your default committee, meeting time, and meeting location will appear at the top of the screen, for today's date. Change the meeting date in the date field at the top of the screen.
