# **Engineering Telework Policy Update**

Engineering Leadership has made some updates to Engineering's Telework Policy (companion to the City-wide policy

covered under APM 2-34), and the revised policy can be found on GEAR. The main changes are summarized below, and are highlighted in the attachment. At the end of the attachment is the Appendix A, which lists the telework eligibility by position. We will also work to get this updated policy posted on <u>GEAR</u>.

- Allowed telework hours up to a maximum of 60% for eligible employees
- Added language for Comp Group 15 employees, currently covered under a pilot telework policy through the winter of 2023/2024
- Added language regarding temporary modifications to telework agreements
- Added language on the expectations to accurately record time using Kronos

If you work in a position that is eligible for telework and you would like to update your current schedule or start a new telework schedule based on the changes to the policy, please discuss with your supervisor and complete a <u>Telework Agreement Form</u>.

Public works engineers are continuing to work on 2023 and beyond projects. Private development Engineers and Managers continue to service contracts and issue plan sets. Plans issued this month include 215 N Fair Oaks, 3841 E Washington, 1309 Williamson St, 4649 Verona Rd, 4002 Lien Rd & 3914 Monona Dr. Hawthorne Ct, Segoe/Sheboygan & Owen Traffic Calming was approved by Transportation Commission. A significant revision to ordinance 16.23 which specifies street and roadway dimensions for new developments was approved by the Common Council.

#### **Operations – Sewer and Stormwater Utilities**

*Kathy Cryan, Deputy Division Manager, Operations, Admin, and Personnel* It was a busy July.

We had major changes in our office at Emil. Danielle Dixon joined our team as Human Resource Coordinator. Kong Vang was promoted to Accountant 1 Trainee. And Cindy Hemenway keeps talking about retirement. We keep ignoring her in the hope she will not actually retire.

TelDig, the software we use to receive and process locate tickets from Diggers Hotline, was unexpectedly taken out of service in late June. A big thanks to John Toso, Tom Archambault, Val Grieshammer, and Josh Sherrod for all their extra work to continue getting this critical work done despite significant challenges. Thankfully, we had already selected a new vendor and just needed to accelerate the contract process. And thankfully we had Candice who was able to get us through the internal processes to finalize an agreement with the vendor in just one month. We also experienced the worst air quality Madison I can recall. In response we're working on developing an Air Quality Job Action Sheet (JAS) to guide us when there are future AQ alerts. The Ops Workplace Improvement Team will be meeting to discuss and provide input.

And finally – it rained! Crews are now working on clean up from the recent storms. A lot of debris has to be removed from larger grates in the system so they can handle next storm event. Our hot box was down for a month and is now back in service so crews are working full speed on catching up on asphalt patching for our utility cuts. Sewer cleaning is on track and we're keeping our heads above water with repairs and CCTV inspection.

MI-TE Program participants are currently working on asphalt patching crews to learn how we restore utility cuts and preserve the life of our pavement. Exposure to career opportunities in Public Works and creating pathways to permanent employment with the City is one of the primary goals of the program. And it looks like the program is off to a good start in meeting this goal. Recently, we had our first MI-TE Program graduate as Nelson Rodriquez was hired into a permanent position with the Streets Division. Congratulations, Nelson! And looking forward to more MI-TE grads joining our Public Works teams!

#### Stormwater

#### Janet Schmidt, Principal Engineer, Section Manager

Robin Greenway and Wexford pond dredge have both been bid and awaiting contract award. Those will kick off late summer and fall, respectively. We recently had some heavy rains that have tested out our storm system. Glad to see it rain but we don't need it all at one time... on a Friday night nonetheless! We are working with USGS on a pilot program for flood alert texts and we received 14 in one evening from all over town. The system seems to be working and if it is a successful pilot we may try to implement citywide. If we can get that system running it could be a handy tool for staff and emergency management, especially when it comes to street closures. Private project work is still going strong with many projects still gearing up this year. We already had several public meetings and a few more on the calendar for this summer that will keep projects moving forward, including several watershed studies. Fall and winter bring one of our biggest greenway reconstructs – Mendota Grassman Greenway from Old Middleton Rd to the Lake. It's taken a long time to get the project designed and permitted but looking forward to getting it started. We are also working on revised ordinance language for CH 37, which is our stormwater and erosion control regs. We are hoping to get some language in our ordinances related to encroachments into greenways and stormwater properties. These changes will be very helpful for managing and tracking these issues that always take so much staff time. If we get support by policy makers those changes will proposed in 2024 and we anticipate at a minimum several months of reviews and approvals.

#### Sanitary Sewer

#### Mark Moder, Principal Engineer, Section Manager

The City street projects for 2023 have now been designed and are now under construction or will be under

construction soon. Design staff are working on plan revisions to projects as utility conflicts with the proposed storm and sanitary improvements are discovered. There is only one stand-alone sanitary sewer project remaining for 2023: Parkside Drive sewer. After we receive soil borings, we will plan to bid.

Lift Station Projects: Harper Lift Station (replacement) is just about done. It is anticipated that the Thurber Lift Station will begin construction in August. The third lift station replacement project, Truax Lift Station, is under contract but will not begin until 2024. All three of these projects are being built by the same contractor. Private development work (lot redevelopment and plat work) continues to be steady with sewer design staff continuing to stay on schedule for sewer extension permitting. We are seeing new apartment developments requiring sewer upgrades to larger diameter sewers. Some of these apartment developments will result in City bid sewer projects -Lake Street Garage Redevelopment, Gardner's Bakery Redevelopment.

Finally, we have advertised and interviewed for a new utility design engineer for the sewer section to fill the position vacated by Matt Allie. We hope to make the selection and have the new employee working soon.
