### Help Make M365 Process Smooth, Clear Out Emails

IT is doing a number of system updates, one being a migration of email as part of the M365 Upgrade. One thing IT wants all employees to do is clean up email inboxes. Here are some easy ways to delete a lot of emails at once. Sort by user:

- Are there some users that just send FYI emails that you don't need to keep Think fuel availability from Fleet, EAP/other newsletter availability alerts, IT Maintenance alerts, etc. Sort email by the user, then you can just grab a whole bunch and delete.
- Also if you have personal emails from someone, forward them to your personal account and delete. Remember all emails are subject to open record requests.
- Look for emails from software vendors and delete those

Same as by Subject - If you regularly converse with someone, but they also send out blasts for maintenance, news, etc, you can sort or search by subject.

Sort by Size – Save off large attachments to the server.

Sort by date - Most of us (yes, Fries, you are the exception), don't need emails from 15 years ago.

Moving forward – try to keep your inbox as clean as possible. Try to get into the habit of reading and deleting right away. If you send out project emails, try and keep the subject line consistent, so it is easier to search or sort. You can't control what others do, but you can keep yours organized. If an email is important, you can save it as a msg file and save it to the project folder.

Zoom automated captions generate real-time captions during your meetings, providing an inclusive and accessible environment for all participants.

#### Stormwater

#### Janet Schmidt, Principal Engineer, Section Manager

Ops crews are working on some waterway and flood mitigation projects for us. One in particular was a long time coming - Regent Street/Kenosha culvert replacement. The corrugated pipes were in very poor shape and the new pipe should offer flood benefits to the neighborhood. Thanks to the crews for getting that done! As the days are getting shorter our design season is ramping up with several projects in the works for fall bids. We will certainly be busy and look forward to getting our Engineer 1/utility designer position filled. We are working on putting a contract together for epoxy repairs for the box culvert on University Ave- we have never tried this technology so we are hopeful it works well and we can use it in other places with aging boxes. Our watershed studies along with our Stormwater Vegetation Management Plan are continuing to move forward with more public meetings coming up this fall. Lower Badger Mill Creek Pond (west of Hawks Landing) is nearing completion. The ponds, channel and bridge are in place and a contact for next year will install the street that will go between Hawks Landing and Meadow Road. Robin Greenway culvert replacement and vegetation restoration is in full swing. Pretty soon the Wexford pond dredge will be kicking off. They are still in the process of relocating the turtles and frogs prior to the construction activities this fall. We will begin our stormwater quality citywide modeling pretty soon (TMDL model), which is required for the citywide stormwater permit. That is a huge amount of work (almost 2,000 hours the last time we did it!) Hopefully we have a more streamlined process this time due to all the hard work by the team last time to make process improvements to the workflow.

#### **Sanitary Sewer**

### Mark Moder, Principal Engineer, Section Manager

The 2023 construction projects for the most part are now winding down except for private development which is still steady with infill site redevelopments and plat development design work. Some of the infill developments are resulting in larger regional infrastructure projects that will be bid by the City- Lake Street Garage Redevelopment (Lake St. and Dayton St. Sewer), Gardners Bakery Redevelopment (Commercial Ave.(Hwy 30) sewer crossing), 1617 Sherman Ave. (Fordem-First St. Sewer Replacement), & 838 Williamson St.(S. Paterson St. Sewer Replacement). We are anticipating this trend of necessary sewer improvements to continue as we continue to see apartment growth along the City's key transportation corridors with the roll out of the Transit Oriented Overlay Zoning with the Bus Rapid Transit.

Lift Station Projects: Thurber Lift Station is now set to start in early October. The Truax Lift Station, is under contract but will not begin until 2024. We will be looking to hire a consultant engineer for the Badger Lift Station this Fall. Project assignments for 2024 construction year are now out.

The focus of the Finance section has transitioned back to the day to day accounting functions with an eye toward making sure everything is proceeding toward the eventual closing out of 2023. On the budget front, the 2024 Capital Budget process recently hit the Finance Committee Amendment phase with three amendments being proposed for Engineering. The next phase will be the Common Council Amendment Phase, with budget adoption the week of November 13<sup>th</sup>. On the Operating Budget side, the Mayor's Executive Operating Budget is set to be Introduced on 10/3, with Finance Committee Amendments the week of October 9<sup>th</sup>. Now that we are getting closer to the end of the year, our budget is getting tight. Purchases of supplies, particularly in the General Fund, should be scrutinized/delayed until next year if possible. This is especially true if the items purchased will primarily be used/needed in 2024. The CCB transition to Kronos is going very well. A big thank you to everyone at ESB for teaching us how it works! A few tips to share:

\*As you're completing your timecard, remember it's ok to have multiple In/Out times for the day, for approved appointments, etc. Use plus sign to left of date to add multiple blocks of time worked. It's ok if your approved schedule that day is different the schedule that's programmed in Kronos.

\* Before approving your timecard, check that the variance column is blank, and the Activity column shouldn't have any unallocated time 0000000/000000/00000.

\* The In/Out/Activity/Duration columns are only for times you worked. The Pay Code/Amount columns are for leave time or Comp Cash out.

\* Auto lunchbreak can be removed on a particular day if needed, say if you grabbed lunch while on the way to an appointment. Contact Jen Wright or Kong Vang for removal.
