WHAT IS A 1095-C?

Form 1095-C provides information about the health coverage offered by your employer and whether you enrolled in this coverage. You do not need the 1095-C to file your tax return.

WHY DOES MY LAST PAY STUB NOT MATCH MY W-2?

Your pay stub shows all earnings paid on a paycheck including non-taxable payments.

The W-2 is all *taxable* earnings.

Box 1 is your Federal taxable wages and can be calculated by taking your total earnings, subtract non-taxable earnings (trip settlements, mileage, work comp), and subtract pre-tax deductions (health ins, flex, def comp, dental, WRS).

Box 3 is your Social Security

taxable wages, and this may be different from box 1 by the amount of your deferred comp.

Gross wages are reported to WRS.

WHAT IS A MUNIS IDENTIFICATION NUMBER?

A Munis ID # is a unique number that has been assigned to you in the Munis software used by the City of Madison to manage financials, procurement, human resources, payroll and revenues.

You can find your Munis ID# on the top left corner of your pay stub, or you can ask your Payroll Clerk.
