

The City of Madison Fiber Network is foundational infrastructure for all City departments and facilities. We rely on the City's fiber network to support critical systems, communications and applications.







What is the Metropolitan Unified Fiber Network (MUFN)?



MUFN provides middle-mile fiber connectivity. It is a local collaborative fiber-optic network serving Dane County area anchor institutions, such as education, health, utilities, government (including public safety), libraries, and nonprofits.



MUFN provides middle-mile infrastructure which unifies and increases existing telecom resources to facilitate enhanced Internet, point-to-point connectivity, and application sharing throughout Dane County and beyond.







## **Impact**

- Loss of connectivity to vital services across the MUFN eco system.
- Loss of connectivity to local public safety agencies.
- Loss of communications to 911 and emergency radio services.
- Loss of connectivity to traffic signals, security cameras and traffic cameras.
- Loss of connectivity to UW Health
  & Meriter Hospitals and Clinics.



#### **Prevention**

#### **DURING CONSTRUCTION**

- Locate markings if they are not visible, call-in to get new locates.
- Communication reaching out to City Inspectors when you are not sure of the locate markings.
- Reporting if you hit, hook, crush or bore through the conduit and/or fiber, reach out immediately. It is far easier for us to address, as soon as we know.

# **Moving Forward**

#### **EXAMING OPTIONS FOR LIQUIDATED DAMAGES**

- Cost Recovery & Liquidated Damages for fiber impacts both the penalties and recovery of City costs to respond to and repair damaged fiber.
- Public Safety & Convenience impacts to Public Safety operations.
