Re: Proposed Street Reconstruction Project and Public Informational Meeting

The City of Madison is proposing to reconstruct Davies Street and Dempsey Road from Buckeye Road to Cottage Grove Road in 2023. A map of the project area can be found on the reverse side of this letter. The proposed project would include replacement of the underground City utilities (water main, sanitary and storm sewers) along with replacement and installation of street infrastructure (curb & gutter, asphalt pavement, sidewalk, driveway aprons, etc...). The City will hold a virtual public input meeting on this proposed project at the date, time, and location noted below. At the meeting, City staff will present information on all of the work that would be included with the project, information on assessments, project schedule, construction information, etc.
