Proposed Design

Goals

- Improve pavement quality.
- Improve existing roadway drainage conditions with curb replacement.
- Improve pedestrian ramps to accommodate all users including people with disabilities.

Proposed Design

- Underground Utilities
 - Storm sewer improvements including new pipes and inlets to alleviate the drainage issues.
- Streets & Sidewalks
 - Replace all existing pavement.
 - Spot replace curbs and gutters that are damaged or have drainage issues
 - Replace driveway aprons as needed due to condition.
 - Replace sidewalk in poor condition.
 - Replace all pedestrian ramps not meeting A.D.A. design standards.



Impact on Trees

- Forestry has already removed the trees that were in poor condition. No more tree removals are planned at this time with the project.
- City Forestry will prune the trees within the project limits prior to the start of construction.
- If, during the course of construction, it is determined that any additional trees must be removed, adjacent property owners will be notified, prior to removal of the tree.



Construction & Access

- Construction is expected to begin in early May.
- Construction will have a duration of approximately 6-8 weeks.
- Roads will be closed to thru traffic during the project.
- Local traffic will remain open during construction except during paving operations.
- Residential driveways may be closed up to 20 days for concrete installation, but at his time there are no driveway removals planned for the project.
- Commercial Driveway access will be maintained at all times.
- Allowed working hours are 7:00 am to 7:00 pm Monday Saturday and 10:00 am to 7:00 pm Sundays.
- On street parking will not be allowed during construction hours.



Construction & Access

- Most of the terraces in the right-of-way will not get disturbed during construction, except at locations of the new storm sewer installation.
- Please remove any plantings, raised beds, structures, stone landscaping, retaining walls, pavers, railings, etc. that you wish to save from the terrace prior to construction.
- Contractor will not replace/reinstall these items.
- Disturbed areas will be restored with topsoil, seed, and matting.



Assessment Policy & Costs

Updated Street Assessment Policy

- Assessment cost per property will vary depending on the property frontage length.
 - Properties assessed for pavement resurfacing (10' width) based on property frontage
 - Essentially eliminates assessments for Curb & Sidewalk.
 - Assessed costs for specific items are based on an average of bid prices from the last 3 years of projects = standardizes costs, removes bidding variability.



Assessment Policy & Costs

- Final assessment billing sent the summer after Construction (2024 for this project)
- Assessments are payable in lump sum or in up to 8 installments at the current interest rate (4% in 2023)
- Residents can contact the project manager for additional details.

- January 17, 2023: Common Council Hearing
- January 26, 2023: Advertise for Bids
- May 2023: Begin Construction
- June 2023: End Construction
