
TO: Property Owners within 100 Feet of 5127 Lake Mendota Drive.

**SUBJECT: PUBLIC NOTIFICATION REGARDING THE TRIMMING, PRUNING OR
REMOVAL OF TREES WITHIN THE PUBLIC RIGHT-OF-WAY OR ON PUBLIC
LANDS**

Purpose: The citizens of Madison have expressed their keen interest and concern for the development and welfare to the City's urban forest, with particular emphasis on the trees within the public right-of-way.

Section 10.101 of the Madison General Ordinances provides for the advance notification of residents regarding the trimming, pruning or removal of trees within the public right-of-ways or on public lands. Operations by the Departments of Public Works and Transportation are exempt, provided that work is under the direction of the City Forester.

The construction and maintenance of public facilities are performed in accordance with the requirements of several different statutes and ordinances. Different notification procedures are required and it is preferable to integrate issues regarding the trimming, pruning, or removal of street trees, as such issues are relevant to the facility or service being provided.

It is the purpose of this APM to establish the public notification procedures for the trimming, pruning, and removal of trees required by the construction and maintenance of public facilities by City divisions, departments and their employees.

Notification Procedures: The public notification procedures for the trimming, pruning, and removal of trees required by the construction and maintenance of public facilities by City Divisions, Departments and their employees are included in Table 1, entitled Public Notification Procedure for Tree Trimming, Pruning and Removal, which is attached to and made a part of this Administrative Procedure Memorandum.

Failure to comply with the notification requirements of this procedure shall be considered misconduct and shall be subject to remedial action, which may include discipline, up to and including discharge.

Non-Assessable Public Works Improvements including street pavement seal coating, crack sealing, bike paths, bridge repair or repairs by City forces or contractors.
