SE side of Nakoma Road from Tumalo Trail to 3821 Nakoma Road



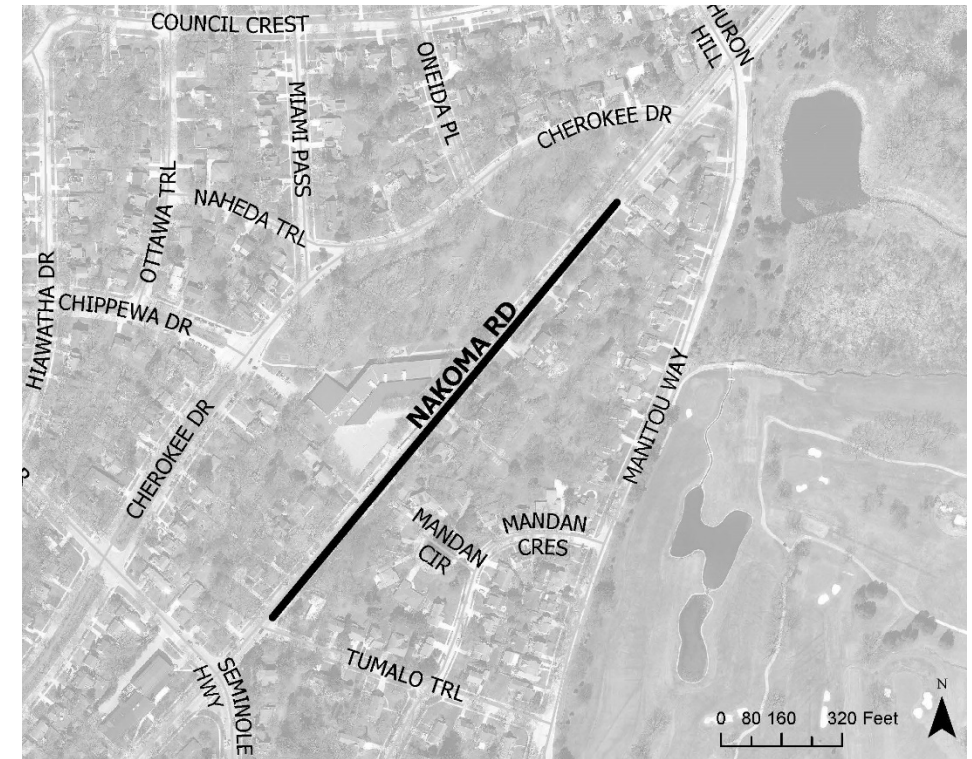
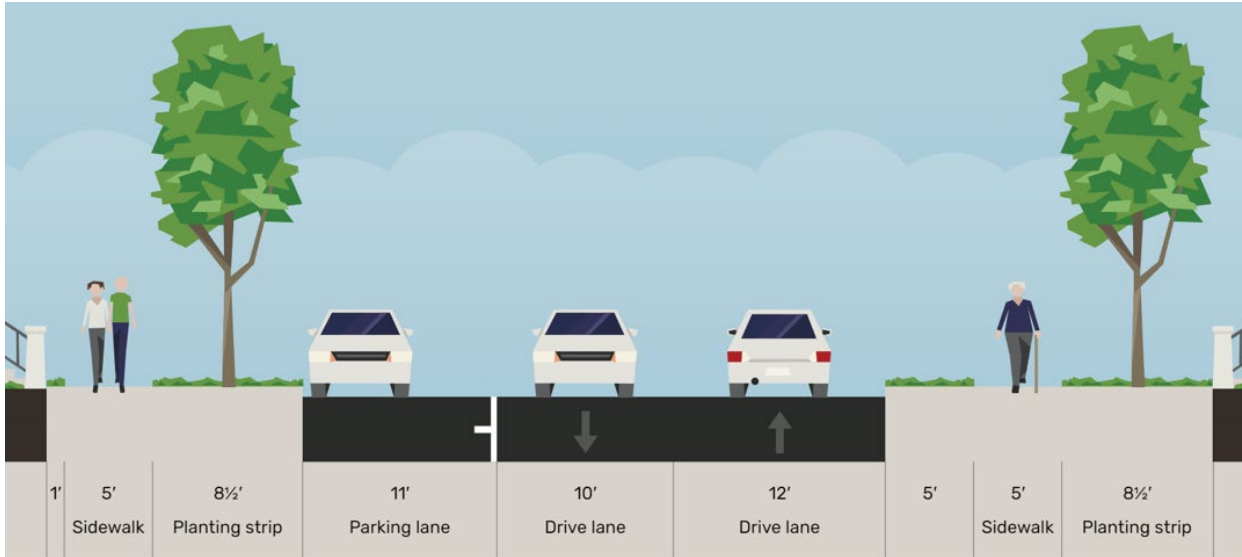

# Proposed Sidewalk Design

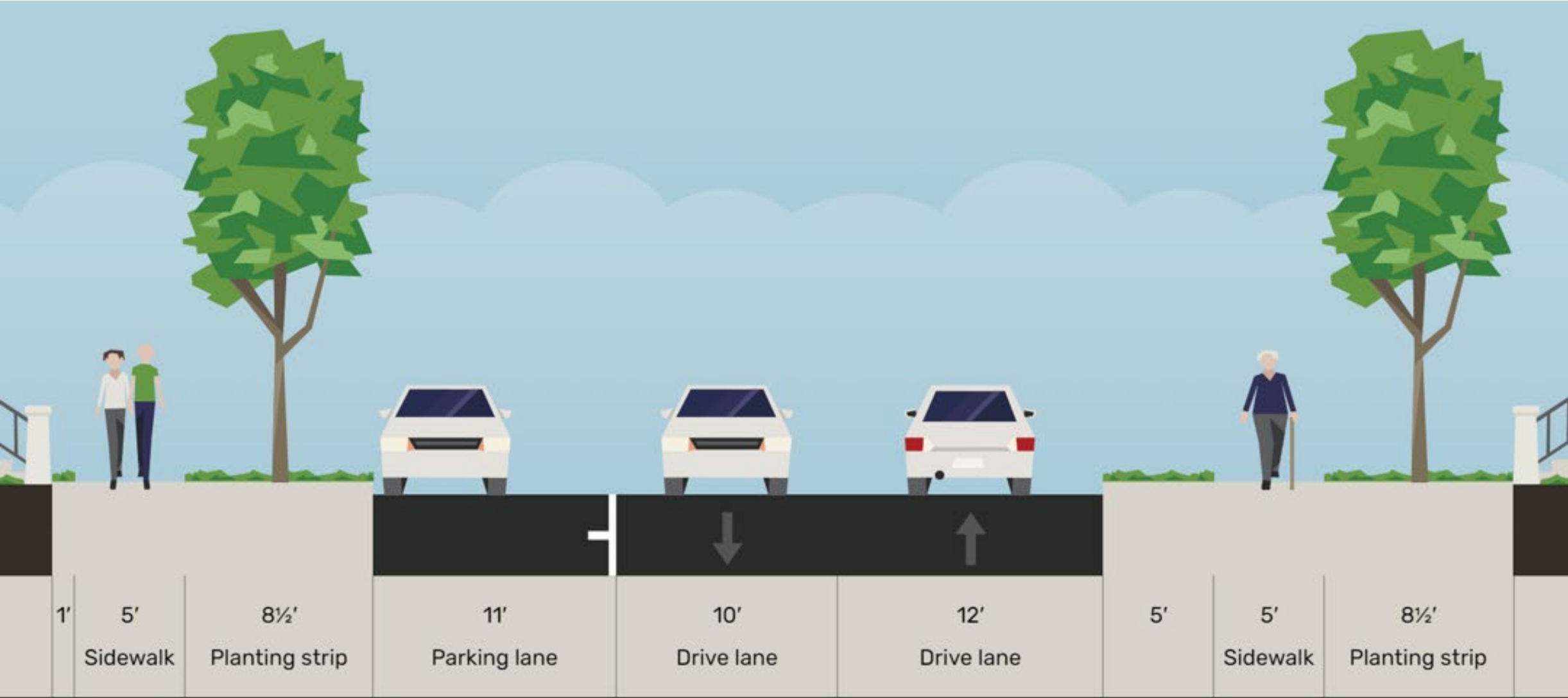
- Sidewalk Installation
  - Curb Bumpout of 10'
  - 5' Sidewalk
  - 5' Terrace (space between sidewalk and curb)



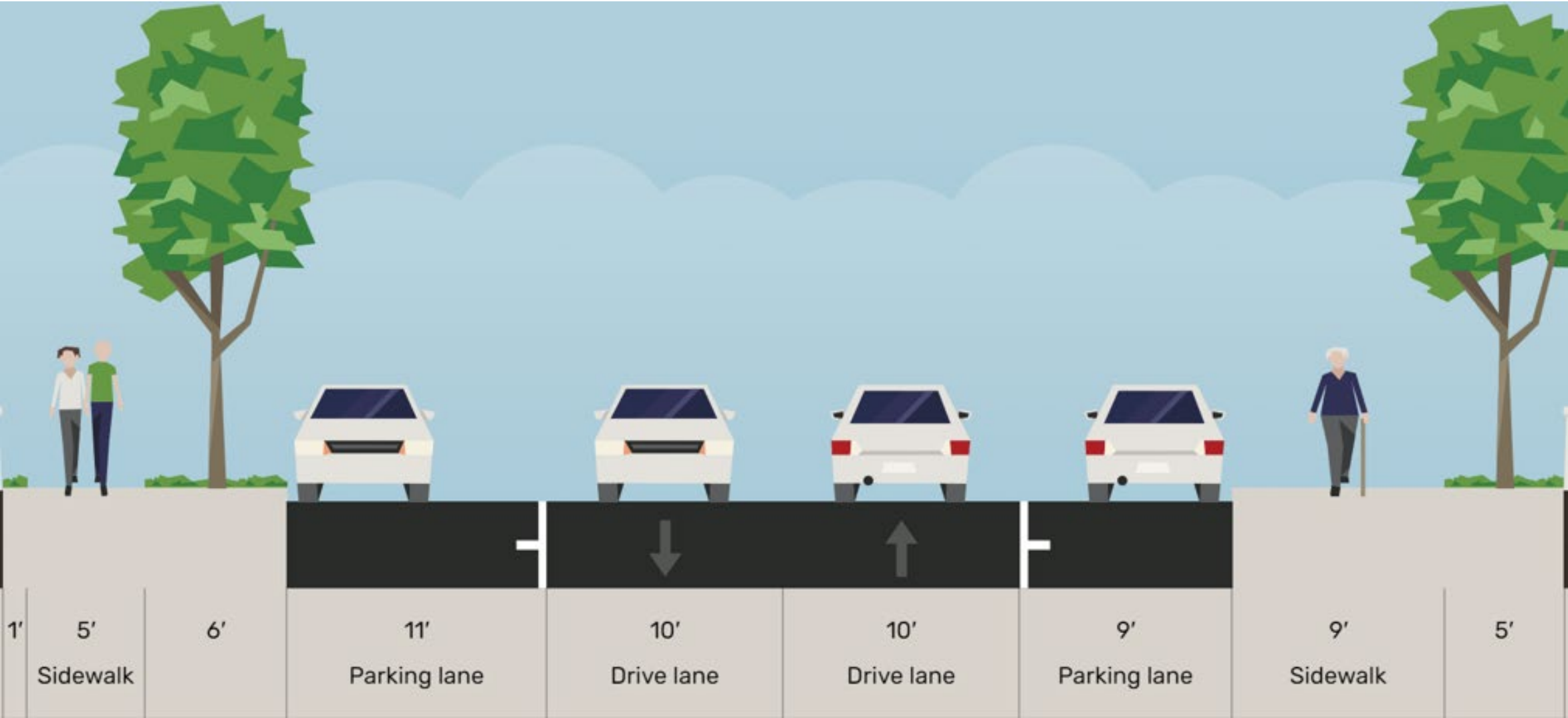
- Street Layout
  - 32'-33' wide with parking to remain on NW side
  - 24' wide at crossing/bumpout areas



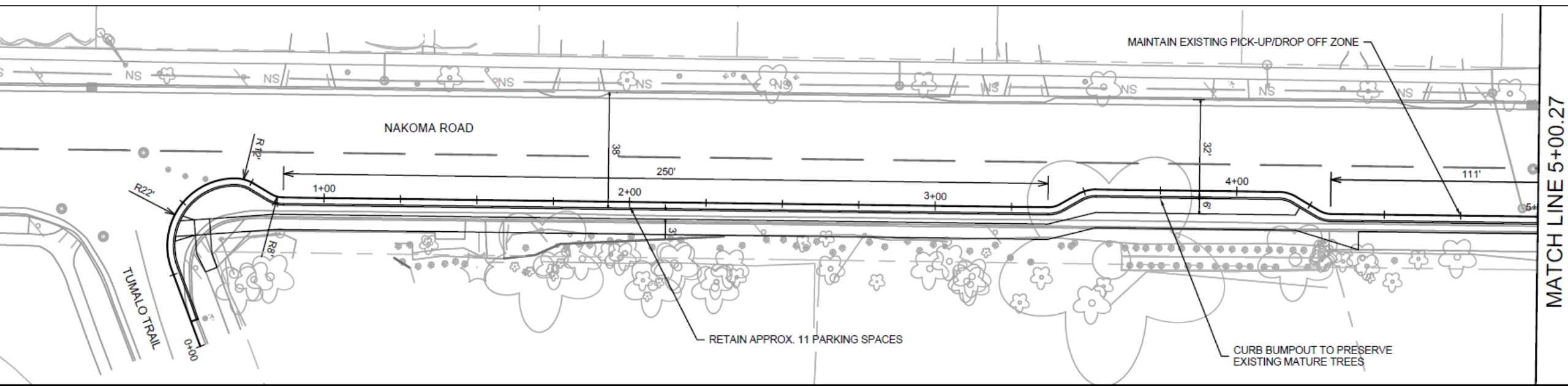
# Proposed Sidewalk Design, Typical



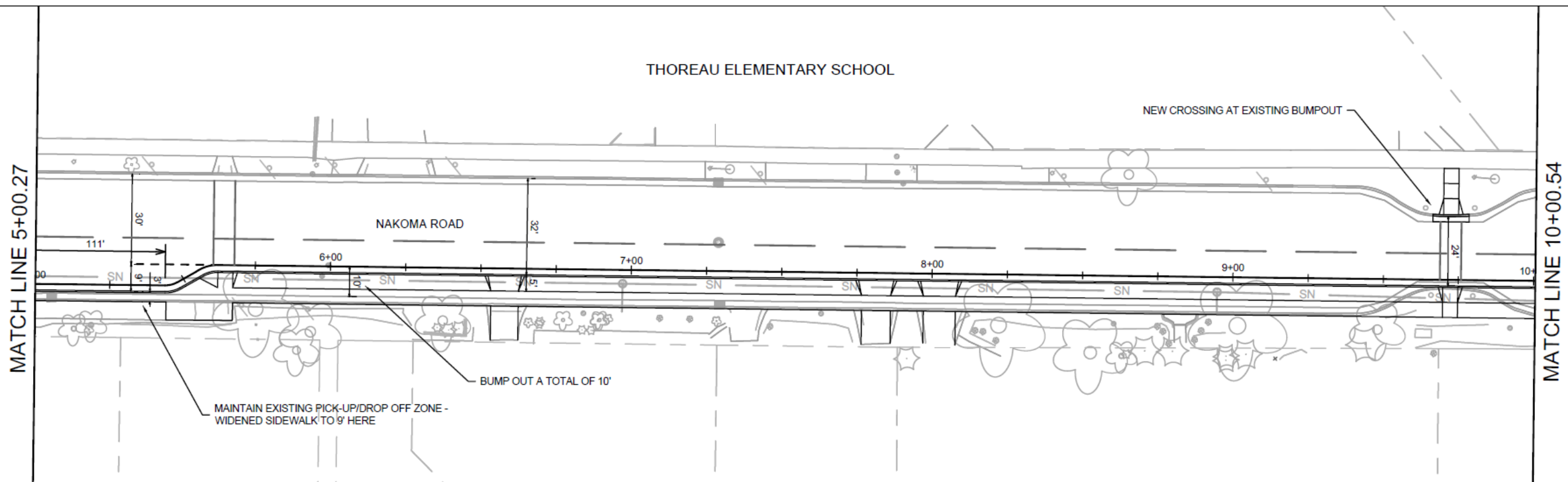
# Proposed Sidewalk Design, Pickup Zone



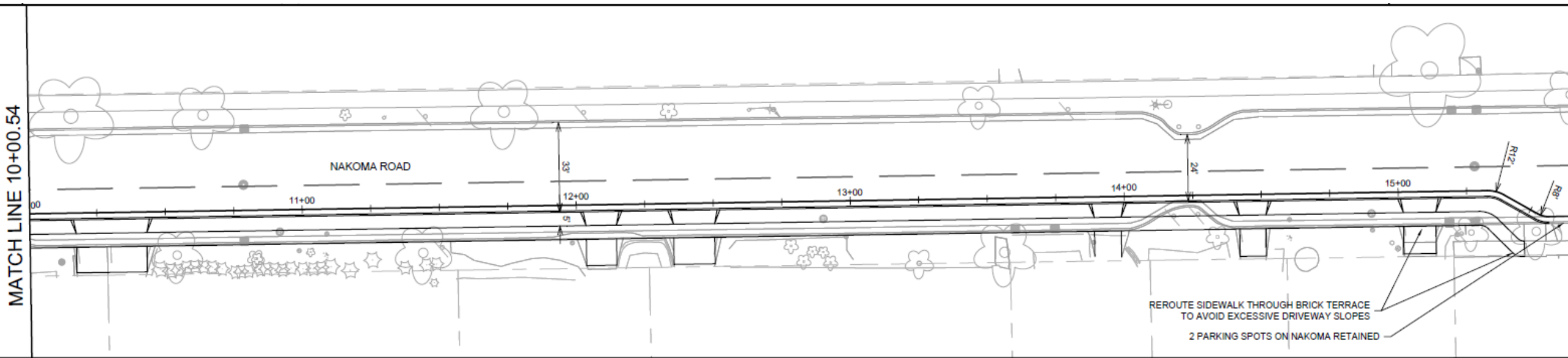
# Proposed Sidewalk Design, Plan View

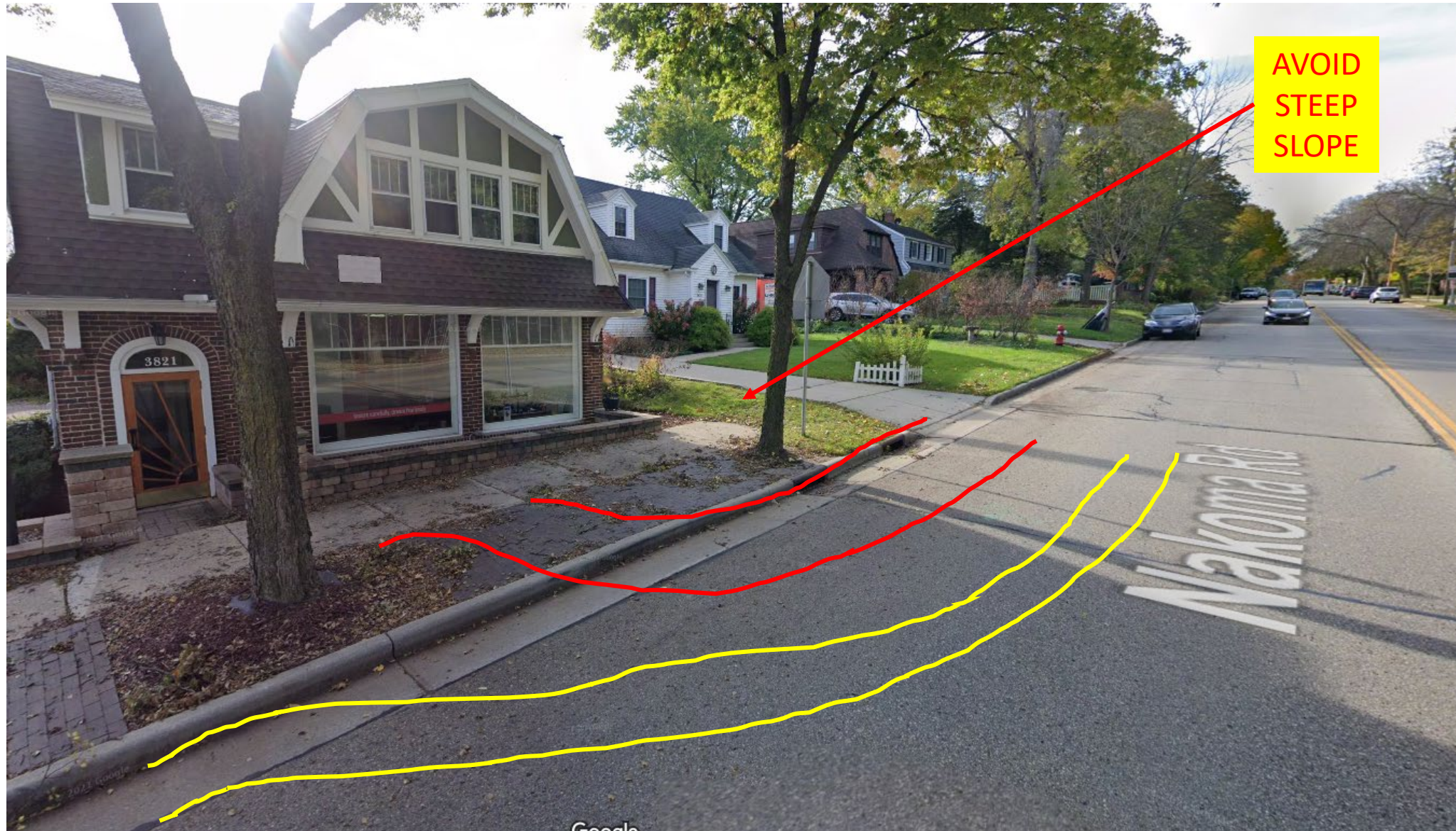

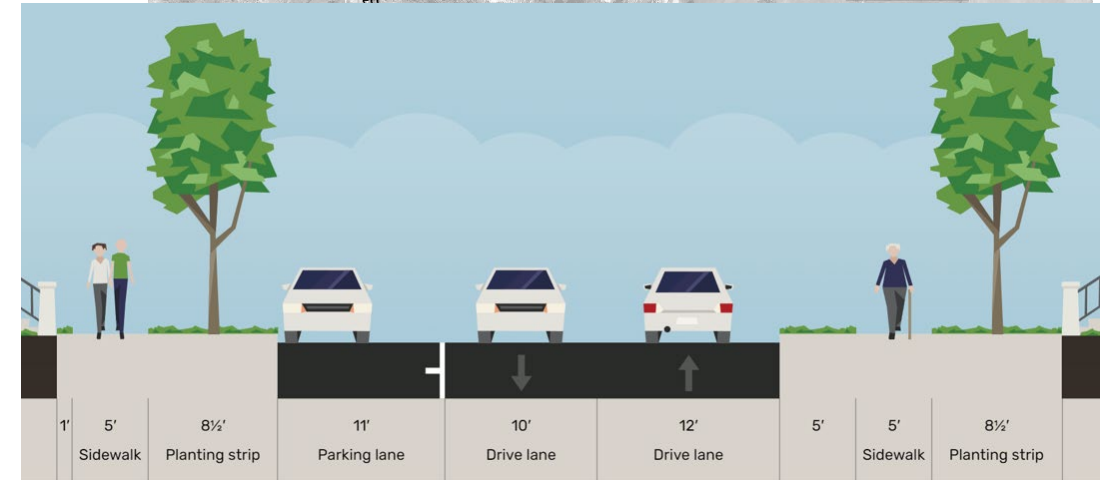
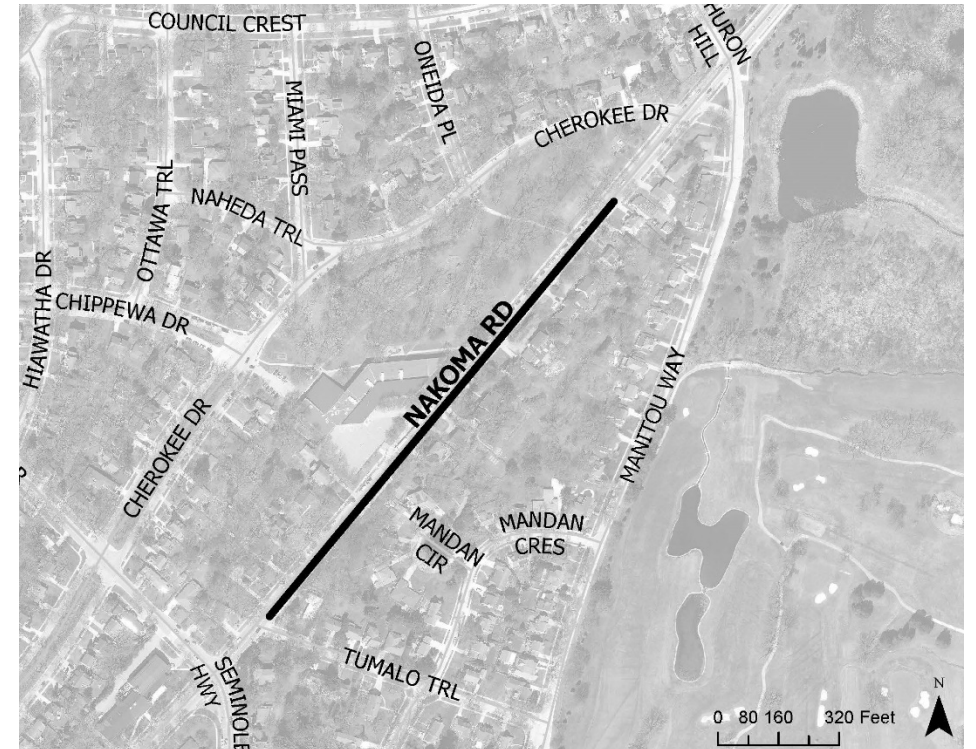
# Proposed Sidewalk Design, Cut through brick terrace





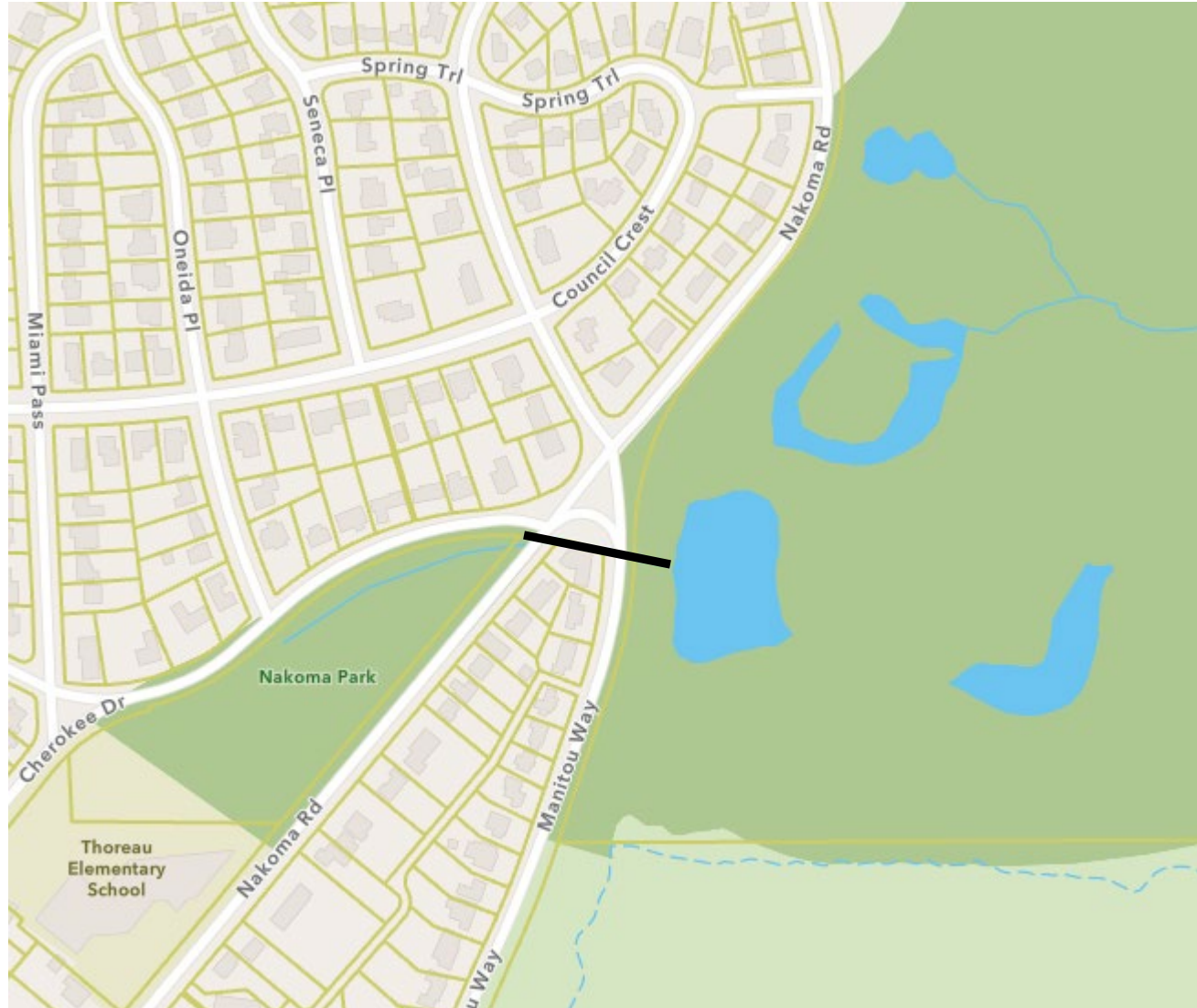
# Proposed Sidewalk Parking Impact

- Parking on NW side unaffected
- Drop-off area on SE side maintained
- Parking on SE side between Tumalo Trail and Manitou Way Impact:
  - Current Parking Spaces: ~47
  - Parking Spaces Retained: 13
    - 11 south of the drop off area
    - 2 just north of the project limits



# Manitou Box Replacement

- Existing 6'x4' concrete box culvert to be replaced with 7'x14' concrete box culvert
- Box replacement to be bid and constructed with the Nakoma sidewalk project
- A separate Public Information Meeting will occur on a later date with more specific details of the box replacement project





# Shawnee Pass - Project Location and Assessment Note

Shawnee Pass from Nakoma Road to Cherokee Drive

There are no assessments for the Nakoma Road Sidewalk.



# Shawnee Pass – Existing Conditions

Item	Existing Condition
Last Surfaced	Surfaced 1996, Crack Sealed 2004
Pavement Surface Evaluation & Rating	3/10 – structural improvement required, over 50% of pavement is cracked & deteriorated
Curb Rating	3/10 – curb is deteriorated and overlaid
Width	22'
Surface	Asphalt
Sidewalk/Sanitary/Water	None
Storm	Only at Limits
Right of Way	30' wide
Street Type	Alley

# Construction & Access

- Residential driveway access will be maintained during most of construction but closed up to a cumulative total of 20 days, residents are notified before
  - Not accessible when contractor is working directly in front
  - Closed when curb, sidewalk, and driveway apron installed
- Allowed working hours are 7:00 am to 7:00 pm Monday-Saturday, & 10:00 am to 7:00 pm Sundays
  - Street parking allowed outside of working hours only
- Construction:
  - Summer 2025: *Approx 3 months*
  - Contract will require construction to begin after school is let out for the summer, and complete before school is back in session in the fall
  - Contract will coordinate traffic control with adjacent sewer project at Nakoma and Cherokee Drive

# Project Schedule

- January 17, 2025: Mail Estimated Assessment (SHAWNEE PASS ONLY)
- January 29, 2024: Approving Plans, Specifications, and Assessments; Board of Public Works Hearing
  - Public may attend to provide input
- February 11, 2024: Approving Plans, Specifications, and Assessments; Common Council Public Hearing
  - Public may attend to provide input
- February 27, 2025: Contract advertised for bids
- June 16, 2025: Anticipated start of construction
