Pleasant View Road Reconstruction Project

Welcome to the first Public Involvement Meeting (PIM) for the reconstruction of Pleasant View Road. The City of Madison, in partnership with the City of Middleton, is proposing a project to reconstruct 2.5 miles of Pleasant View Road from Mineral Point Road to US 14. Representatives from the project team, including the City of Madison and City of Middleton, are available to address your questions and concerns. This meeting is an open house format, and a presentation will be given. Additional public involvement meetings will be held as the project development progresses through the design phase. Prior to the beginning of construction, a final public meeting will be held.

Purpose of the Meeting

The purpose of tonight's meeting is to introduce the proposed conceptual design and intersection alternatives, answer questions, and listen to your comments, concerns, or suggestions. This is an opportunity for you to offer input into the design process. It also provides an opportunity for you to review the proposed design and the potential impacts. Please review the exhibits around the room. You are also welcome to write down your comments on the comment sheet available at the sign-in table. Project Overview

The current rural, two-lane design of Pleasant View Road cannot accommodate the current and growing traffic volumes. The proposed project will include reconstruction of the existing roadway as an urban arterial with curb and gutter, a raised median, new multi-use path/sidewalk in selected areas, Americans with Disabilities Act compliant curb ramps, storm sewer, new street lighting, new and replacement of sanitary sewer and water main, new pavement marking, and signing. Stormwater detention ponds will be constructed to control stormwater and improve stormwater quality.

Project Goals

- Provide a safe and functional corridor for all users including motor vehicles, bicycles, and pedestrians
- Address existing roadway deficiencies including substandard sight distances and poor pavement conditions
- Accommodate travel demand from planned future growth and urban development
- · Provide well-designed intersections that minimize impacts
- Integrate the facility into its surroundings with aesthetic design

Traffic Control

During construction, Pleasant View Road will be open to one lane of traffic in each direction. Short-term closures of Pleasant View Road may be required, and a detour would be posted during those times.

Right of Way

Additional right of way and temporary limited easements will be required for this project.

The City of Madison will be assessing property owners in accordance with city policy.

Public Recreational Areas [Section 4(f)] and Historical Resources

The Pleasant View Golf Course is owned by the City of Middleton and is considered a public recreational area, which qualifies it as Section 4(f) property. Impacts are anticipated to this property; however, adverse impacts are not anticipated. Impacts are anticipated to be limited to the rough, taller grass areas located between Pleasant View Road and the golf course fairway. Disturbed areas will be replanted with similar grasses.

The German Lutheran Cemetery, located on the east side of Pleasant View Road approximately 0.25 miles north of Old Sauk Road, is considered a historical resource. Impacts to this property will be limited to minimal grading to clear topsoil and placing earth fill material within the existing road right of way for installation of curb and gutter.

The project team is seeking input on any concerns individuals may have with how the project is impacting these resources.
