The escalator instantaneous step/ skirt index measurements shall be recorded at intervals no larger than 150 mm (6 in.) from each side of two distinct steps along the inclined portion of the escalator, where the steps are fully extended. Test steps shall be separated by a minimum of 8 steps.  Step 1: Left Right: Step 2: Left Right OK Fail N/A Skirt Deflectors: Yes No								
3	ASME A17.1 8.6.8.15.20 Clearance Between Step and Skirt (Loaded Gap): Loaded gap measurements shall be taken at intervals not exceeding 300 mm (12 in.) in transition region (6.1.3.6.5) and before the steps are fully extended.
