ENROLLMENT/CHANGE BASICS FOR 2024

- Third year of all online Flex Spending open enrollment (via ESS)
- Second year of all online Dental and Vision open enrollment (via ESS)

• Health open enrollment \rightarrow via the myETF portal online **or** via paper form to HR

GHC-SCW is splitting into two networks in 2024: **GHC-SCW Dane Choice** (Dane County) and **GHC-SCW Neighbors** (Columbia, Grant, Iowa, Sauk, Jefferson, Juneau and Lafayette Counties). All employees with GHC-SCW will automatically be enrolled in GHC Dane Choice for 2024 **UNLESS** they actively submit a change to enroll in GHC Neighbors.

ENROLLMENT TIPS AND REMINDERS

- You *do not need* to re-enroll in Health, Dental, or Vision Insurance if you are not making changes (no action is required)
- GHC-SCW will split into two separate networks in 2024. If you are enrolled in GHC-SCW and have a primary
 provider or clinic outside of Dane County, you will need to enroll in GHC-SCW Neighbors
- You *do need* to enroll in 2024 Flex Spending if you would like to participate
- All City emails are subject to open records requests; as such, if you are submitting a health change as a hardcopy form, you should do so in one of the following ways:
 - Drop off in person at HR (MMB 261)
 - Fax to HR at 608-267-1115
 - Send via inter-d to HR (MMB 261)
