2020 DeltaVision Insurance Enrollment

Coverage is effective January 1, 2020

2020 Annual Open Enrollment Period is September 30, 2019 through October 25, 2019, 4:30 pm

2020 Monthly Premiums:

DeltaVision from Delta Dental is a new standalone vision insurance benefit for 2020. Premiums will be deducted from the second paycheck of each month for the following month's coverage. There is no employer contribution to premium. **Hourly and Seasonal employees are not eligible for this benefit.**

Single (Employee only):	\$5.97
Employee + Spouse:	\$11.94
Employee + Child(ren):	\$12.19
Family (Employee + Spouse + Child(ren)):	\$18.16

Special Notes

- This is a standalone benefit. You do not need to enroll at the same coverage level that you may have for other City benefits. Example: You could have Employee + Spouse vision insurance, Employee + Child(ren) dental insurance, and Family health insurance.
- Employees who are enrolled in the City's group dental plan will continue to have access to the EyeMed vision discount plan even if they do not enroll in the separate DeltaVision group vision insurance plan.

VISION INSURANCE PLAN INFORMATION

DeltaVision, in partnership with EyeMed Vision Care, partners with easily recognized providers that include major retailers like LensCrafters® or Target OpticalSM as well as many smaller, independent doctors. Retailers offer many conveniences like locations and extended and weekend hours to help members get the service they need, when they need it.

Prescription Glasses and Contacts

Through DeltaVision, you can order prescription glasses and contacts through online retailers like Glasses.com or ContactsDirect.com. The in-network benefit will be applied in your shopping cart and items will ship direct to you.

Annual Exams

DeltaVision offers covered annual exams (with retinal imaging after copay, if applicable), \$130+ frame/lens allowance, 40% off extra pairs of glasses, 15% off LASIK, and 20% off any non-covered item.

Diabetic Eye Benefit

DeltaVision also has a Diabetic Eye Care Benefit that provides access to more frequent and in-depth eye care – helping to detect and minimize vision-related complications early on.

If you enroll in vision insurance coverage, you are committed to being enrolled in the plan for the entire year. Employees may not withdraw from the group vision insurance plan in the middle of the year, except in the case of a qualifying event.

Return the completed vision insurance application to Human Resources, Madison Municipal Building Suite 261, 215 Martin Luther King Jr Blvd, Madison, WI 53703, by 4:30 pm on October 25, 2019. There is no online enrollment option for vision insurance. Due to the volume of forms that we receive, Human Resources staff may not be able to confirm receipt of your application prior to the deadline, if it is not submitted in person.
