<u>Health Insurance</u>: You will receive a monthly bill sent to your home address from Central Payroll. You will be billed the employee portion while on a qualified medical leave. *If your leave of absence is not medically related, you may be responsible for the entire premium.* Premiums are due two weeks from the date of the bill for the following month's coverage. Bills are usually sent out on the first pay date of each month. Please contact HR at 608-266-4615 or Missy (Central Payroll) at 608-266-4677 with any questions or if you do not intend to retain coverage.

<u>Life Insurance</u>: You will receive a monthly bill sent to your home address from Central Payroll. You will be billed the entire monthly premium while on leave. Premiums are due two weeks from the date of the bill for the current month's coverage. Bills are usually sent out on the first pay date of each month. <u>Dental/Vision Insurance</u>: You will receive a monthly bill sent to your home address from Central Payroll. You will be billed the entire monthly premium while on leave.
