PROCLAMATION OF EMERGENCY

WHEREAS, an emergency exists within the City of Madison resulting from civil commotion, disturbances, looting and rioting, and

WHEREAS, this civil commotion, looting, and rioting within the City of Madison presents an imminent threat of disaster which may impact transportation, fire, police protection and other critical response systems within the City of Madison, and

WHEREAS, I, as Mayor of Madison, have the authority pursuant to Wisconsin Stats. §§ 323.11 and 323.14 and Madison General Ordinance Sec. 3.19, to proclaim that a state of emergency exists and to invoke the emergency powers granted by ordinance and state statute,

NOW, THEREFORE, BE IT PROCLAIMED BY THE MAYOR OF MADISON, DANE COUNTY, WISCONSIN:

- That a state of emergency is hereby declared for the City of Madison pursuant to Wis. Stats.
 § § 323.11 and 323.14 and Madison General Ordinances Sec. 3.19.
- That the state of emergency shall be in effect until June 3, 2020, unless extended by mayoral proclamation or resolution of the Common Council, or until the emergency conditions no longer exist if such period is shorter than that identified in this paragraph.
- This proclamation of emergency shall be given prompt and general publicity and shall be filed promptly with the City Clerk.
- 4. This proclamation of emergency activates the City of Madison emergency operations plan.
- 5. That this proclamation shall take effect immediately from and after its issuance.
- That pursuant to the authority granted by the above provisions, I declare the following regulations are now in effect and have the force of law:
 - a. A curfew is hereby imposed at the following times:
 - i. May 31, 2020, at 12:01 a.m. until May 31, 2020, at 5:00 a.m.
 - ii. May 31, 2020, at 9:30 p.m. until June 1, 2020, at 5:00 a.m.
 - b. The above mentioned curfew is in effect for the following locations:
 - 600 N. Park St. south to 900 S. Park St., 1200 W. Lakeside St. east to 300 E. Lakeside St., to Lake Monona shoreline east to the Yahara River; Yahara River north to Lake Mendota, Lake Mendota shoreline west to 600 N. Park St.
 - c. Vehicular and pedestrian traffic is hereby prohibited during the times mentioned in Section a above and in the locations mentioned in Section b above. This does not apply to individuals traveling to residents and places of businesses.

- d. As of May 31, 2020, at 12:01 a.m. all businesses in the following locations are closed until May 31, 2020 at 5:00 a.m.:
 - i. 100-800 blocks of State St.
 - ii. 500-800 blocks of University Ave.
 - iii. 200-400 blocks of W. Gorham St.
 - iv. 200-400 blocks of W. Gilman St.
 - v. 300-500 blocks of N. Frances St.
 - vi. 300-500 blocks of Lake St.
 - vii. 400 block East Campus Mall
 - viii. 200-300 blocks N. Henry St.
 - ix. 100 block of Fairchild St.
 - x. 200 block of W. Dayton St.
 - xi. 100 block of W. Mifflin St.
 - xii. 100-200 blocks of N. Carroll St.

That this proclamation will be presented for adoption at the Common Council meeting of June 2, 2020.
