# What are they?

Put simply, they help families and individuals who earn low-to-moderate incomes keep more of what they earn. They lower taxes, add to wages and make work more affordable. An Earned Income Tax Credit can result in thousands of extra dollars to families- yet every year, many families who think they're not eligible fail to claim them.

### **Don't Miss Out**

Tax payers who have earned income but are not required to file taxes miss out on this credit. Only one in four who are eligible actually apply for an EITC.



# **Very Important - Save Time**

Please bring ALL of the needed items with you to the site. If items are missing, your tax return CANNOT be completed

- ♦ Picture ID (mandatory)
- ♦ Wage statements Form(s) W-2
- Pension and Social Security Statements
  - Form(s) 1099R and SSA-1099
- ♦ All 2013 informational statements, including:
  - Interest and dividends statements— Form(s) 1099INT and 1099DIV
  - Mortgage interest statements— Form(s) 1098
  - Tuition payments statements— Form(s) 1098-T
  - Property tax receipts for any property taxes paid in 2013
- ♦ Copy of last year's tax return, if available
- Information about any other sources of income, both taxable and non-taxable

- Info on all other deductions/credits (include charitable contributions or employee business expenses)
- Copies of actual social security cards for you, all dependents, and spouse if filing jointly
- If homestead credit is claimed:
  - A completed rent certificate and/or copy of your 2013 property tax bill
  - A printout of any Wisconsin Works
     (W2) payments received in 2013
- A record of any estimated tax payments made for the 2013 tax year
- If direct deposit of your refund is desired, a voided check for a checking account or a deposit slip for a savings account
