Emergency Zone is in the Downtown Isthmus area of Madison. The boundaries are Park Street and Brittingham Park on the south and west to the Yahara River on the north and from Lake Monona to Lake Mendota.

# **Common Parking Mistakes to Avoid**



#### Do Not Park ...

- On the terrace (from sidewalk to curb)
- Against traffic
- More than 12 inches
   from the curb
- At a yellow curb
- Within 2 feet of another vehicle
- Within 4 feet of a driveway or mailbox



- Within 10 feet of a fire hydrant
- Within 15 feet of a crosswalk
- On a sidewalk or crosswalk
- On the grass in parks or other public lands
- A vehicle on the street that has expired registration, expired stickers or not displaying valid plates
- Any vehicle, including recreational vehicles, for more than 48 continuous hours on a city street
- Contrary to signs
- A moped or motorcycle on the terrace, sidewalk or in a bike rack
- On Private Property without permission from the property owner/manager
- Vehicles weighing 10,000 lbs. or more on a residential street



# Time Restricted Areas

- Do not park for longer than the posted time limit for that stall or block.
- After you have parked for the allotted time, you must leave the block and not park on that block again that day during the posted times.

## Parking for People with Disabilities

- Only vehicles displaying a valid handicap permit or plates are authorized to park in a posted disabled parking stall.
- Vehicles displaying a valid handicap permit or plates are exempt from paying for metered stalls that are posted 30 minutes or more.
- Vehicles may park past the time limit posted on any street or metered stall if the limit is for 30 minutes or longer.
- Use of the permit does not exempt the vehicle from any other posted restriction.
- Do not park on the striped portion (access aisle) of a parking stall reserved for persons with disabilities.

# **Metered Parking**



- Do not park without making a payment in the meter or pay station.
- Do not park for longer than the time limit posted on the meter stall.
- Do not add money
  to the meter to prevent it from expiring.
- Do not block multiple spaces with an oversized vehicle without paying for each occupied space.

## How to Use Multi-Space Meters

- Step 1: Park your vehicle and note your space number and time limit.
- Step 2: Enter your space number at a Multi-Space Metered Pay Station.
- Step 3: Insert payment (U.S. coins or credit/ debit card).
- Step 4: Press the green button to complete transaction.
- Step 5: Take your receipt and you're done!
