### Watercraft Storage Rules

1. Watercraft must not exceed 80 pounds, 18 feet in length, 42 inches in width, or 24 inches in height.
2. Items stored in the storage area are limited to watercraft only. No unauthorized property is to be stored on the premises.
3. Only one watercraft is allowed in each space.
4. Premises are to be left in the original condition upon termination of the permit period.
5. Permit must be visible at all times on the watercraft. Tarps that block or cover the permit are prohibited.
6. Watercraft must be fully contained within the designated space.
7. Parks staff reserves the right to cut any lock and remove any watercraft, under any condition it deems necessary for the function of the boat storage program.
8. Watercraft must be secured to the boat storage rack. Owner accepts all liability for theft or damage to their property.
9. All sales are final. No refunds. Make checks payable to "City Treasurer."
10. Agreement is valid through March 31, 2021 regardless of purchase date. Current users will have the opportunity to renew before this date.
11. Prices are not prorated.

The undersigned user of the watercraft storage space assumes sole risk for their property. The user agrees to hold the City of Madison, its officers and employees neither liable nor responsible for any loss or damage to the user's personal property, watercraft or associated equipment. The City of Madison further holds the right to hold its officers and employees harmless, and to indemnify and defend the City and its employees against all claims, liability or expense incurred by the City on account of and damage to personal property and/or personal injury caused by or resulting from the operation of the user's watercraft or use of the premises.
