    - ii. The main playground by community garden lacks accessible parking in close proximity a requirement for full accessibility.
    - iii. Opportunity for locating accessible playground to west side of park between bike path and shoreline

- Project Budget
  - a. Significantly more due to costs associated with fully accessible equipment and surfacing
- Equipment and Play Surfacing Selection
  - a. Age Group
    - i. Interest in providing equipment for both 2-5 and 5-12 age ranges at the playground
  - b. Surfacing
    - i. Discussed pro's and con's of each product: poured-in-place rubber, artificial turf, rubber tiles
  - c. Playlines

i. Equipment from three manufacturer's were presented for review. The playline character that had the most number of votes for the accessible equipment was the GameTime product line.

#### d. Colors

i. Discussion of special considerations for colors at accessible playgrounds including wayfinding and contrast for visually impaired and Autistic users
