RE: Judge Doyle Project Quarterly Report

As of the end of the third quarter of 2018, the Judge Doyle Garage construction continues to make considerable progress, reaching the 45% completion milestone. The quarter was marked by progress on all elements of the project as described below.

Judge Doyle Garage Construction

- As of September 30th, the contractor continued pouring the structural decks, columns and walls
 of the parking decks.
- Primarily due to (1) unforeseen soil conditions during the excavation; (2) weather conditions (extreme cold snaps in January and February and wet weather in the spring), and (3) extended preparation to ensure a quality installation of the waterproofing below the slab on grade, the schedule has lagged by 44 days. The lag did not increase during the quarter. We target the issuance of the certificate of occupancy for the municipal garage for August 2019 following the completion of the Podium structure above the municipal garage.
- Six change orders have been approved by the Board of Public Works to date in the amount of \$680,637. The project has utilized 28.4% of the project contingency through the end of the third quarter leaving available contingency of approximately \$1,715,000.
- The City, contractor and architect hold biweekly job progress meetings to coordinate construction activities.
- The tradespeople on site have worked a total of 38,632 hours to date with only one recordable safety incident, which occurred in the second quarter of 2018. To date, workforce utilization is 4.53% for racial/ethnic minorities and .30% for women.
- The project metrics through the end of September 2018 for the garage construction are attached to this report.

Judge Doyle City Staff Team

• The Judge Doyle City Staff Team, formed to support and coordinate the work on the Judge Doyle project among the City departments and divisions, met on July 13th, August 10th and September 14th.

Bicycle Center

- On November 21, 2017, the Common Council approved the selection of Freewheel Bicycle Company of Madison as the bicycle center operator and directed a final lease be negotiated.
- A second and third design meeting were conducted by the architect with City Staff and Freewheel in July and September. The build-out of the bicycle center will be included in the final Podium construction documents, to be considered by the Board of Public Works on November 7th when it reviews the plans and specs for the Podium construction.

 A copy of the bicycle center buildout concept plan is attached to this report. The bicycle center will be located at the corner of East Doty and South Pinckney Streets. The target date for opening the bicycle center is the fourth quarter of 2019.

Block 88 and Block 105 Private Development

- On August 23rd, the developer voluntarily dismissed its lawsuit related to the project as discussed in the Second Quarter Report. Following this action, the City and the developer entered discussions on a path forward to resolve the outstanding issues. The Mayor and City staff have continued to provide regular briefings for Common Council members on the status these legal actions at the Finance Committee. Discussions are ongoing.
- The municipal garage design team has moved forward on the Podium element. Informational presentations were made to the City's Urban Design Commission on June 6th and July 18th about the proposed design changes and feedback was requested. The Landmarks Commission considered the Podium design change on July 9th and found that the design change wasn't visually obtrusive to the landmark Madison Municipal Building. On July 10th, the Capitol Neighborhoods Development Committee reviewed the proposed design change. The application for a major alteration to the approved planned development for the Block 88 portion of the project was filed by the City on August 1st. The Urban Design Commission considered it on September 26th and granted initial approval.

Looking Ahead

- Structural deck construction will continue throughout the fourth quarter on the municipal garage, with construction anticipated to be at grade by the first of the year.
- The application for a major alteration to the approved planned development for the Block 88 portion of the project will be considered by the Plan Commission and Common Council in October. The Urban Design Commission will also consider a request for final approval in October.
- In November, the Board of Public Works and the Common Council will consider (1) a resolution to approve the plans and specs and authorize the Board of Public works to advertise and receive bids for the Podium construction and the build-out of the bicycle center, (2) a resolution to approve Change Order #6 to the Judge Doyle Garage contract.
- LVDA will complete the construction documents for the Podium during the fourth quarter.
- Final sign-offs and the recording of the rezoning documents will be completed in December for the Block 88 PD/GDP and the PD/Phase One SIP. Issuance of a building permit for the continuing Block 88 garage construction is expected in December 2018.
