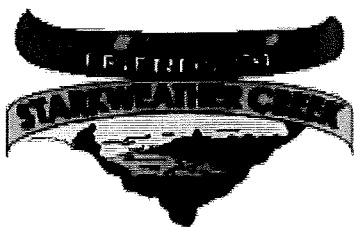

Hello,

Friends of Starkweather Creek (FSC) is concerned about current plans by the Salvation Army to expand parking around their building site on Darbo Drive. The Salvation Army complex at that location has a large existing parking lot. We do not believe that parking usage calls for an increase in the total number of stalls and do not see the west parking lot reduced by the number of stalls added to the east side. Silt from this and nearby paved areas feed directly into nearby Starkweather Creek. The tongue of silt can easily be seen when looking at the creek near Darbo Drive where it crosses the creek.

We understand the rationale for the new handicapped parking close to the gymnasium but see only two handicapped slots. We don't understand safety concerns in parking on the west side of the building and needing to walk along the side of the Salvation Army from the existing parking lot to the gymnasium entrance where primary activities include basketball and dance squads.

The east side of the Salvation Army at this site has been the location for an important and growing community garden. That garden has functioned as an educational vehicle on growing and provided food for the pantry and local residents and its loss is not incidental to the community.

We feel the few green markings on the redesign of the west parking lot – a few trees to provide shade, is inadequate. We would like to see this parking lot meet current runoff standards with any redesign and also include below grade shallow soil wells (rain gardens) that could infiltrate the surface runoff directly into the ground.

Please consider restricting parking at this site and maintaining green space. Please pay attention to the runoff from these sites into Starkweather Creek. Reducing this runoff will help water quality in Starkweather Creek and downstream in Lake Monona.
