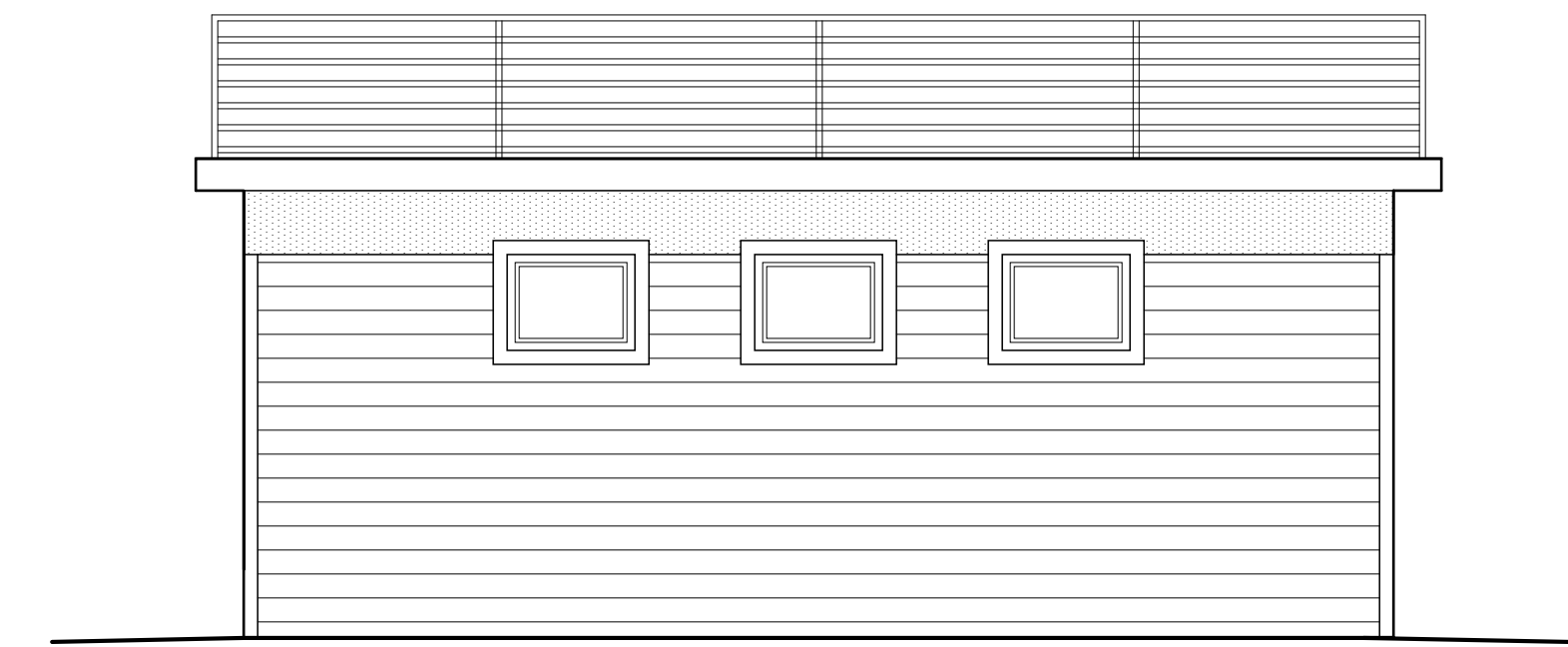

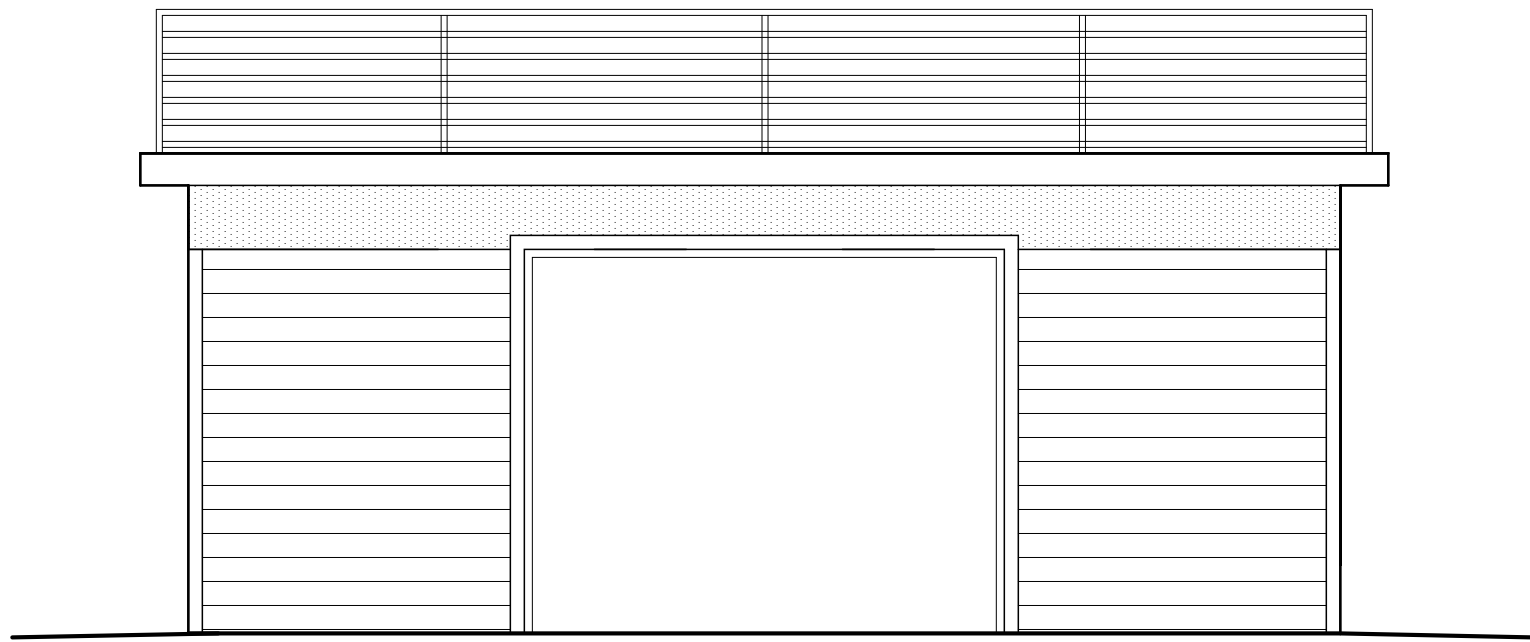

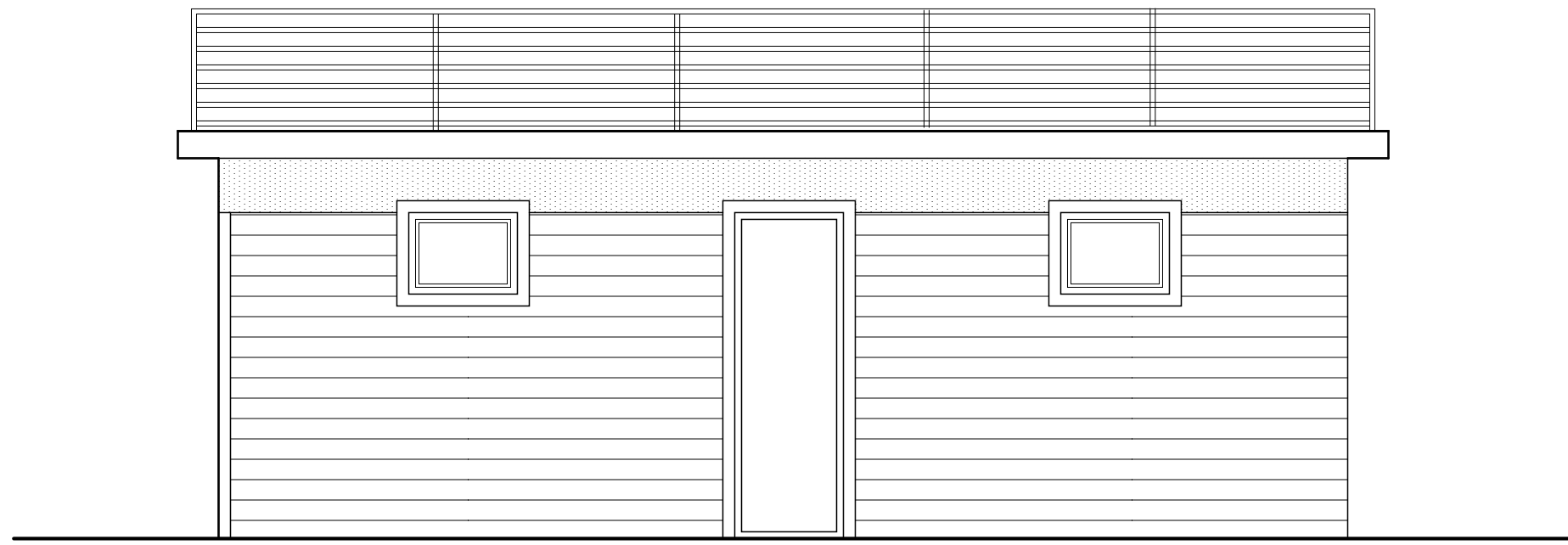
④ SOUTH ELEVATION
1/4" = 1'-0"



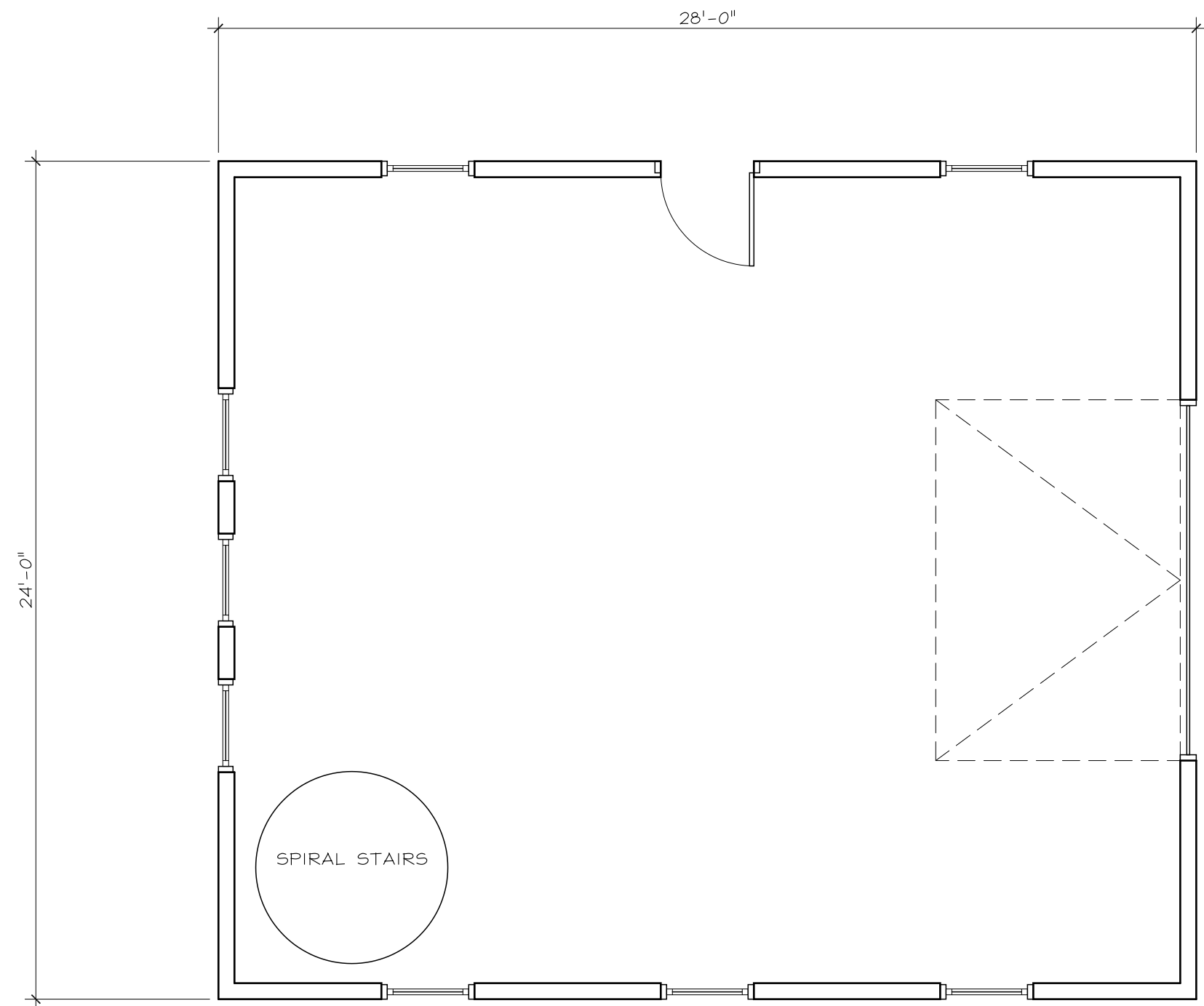
② EAST ELEVATION

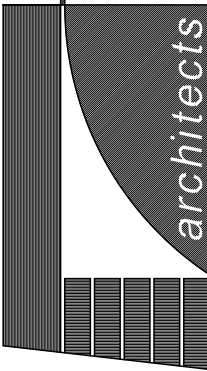
③ WEST ELEVATION

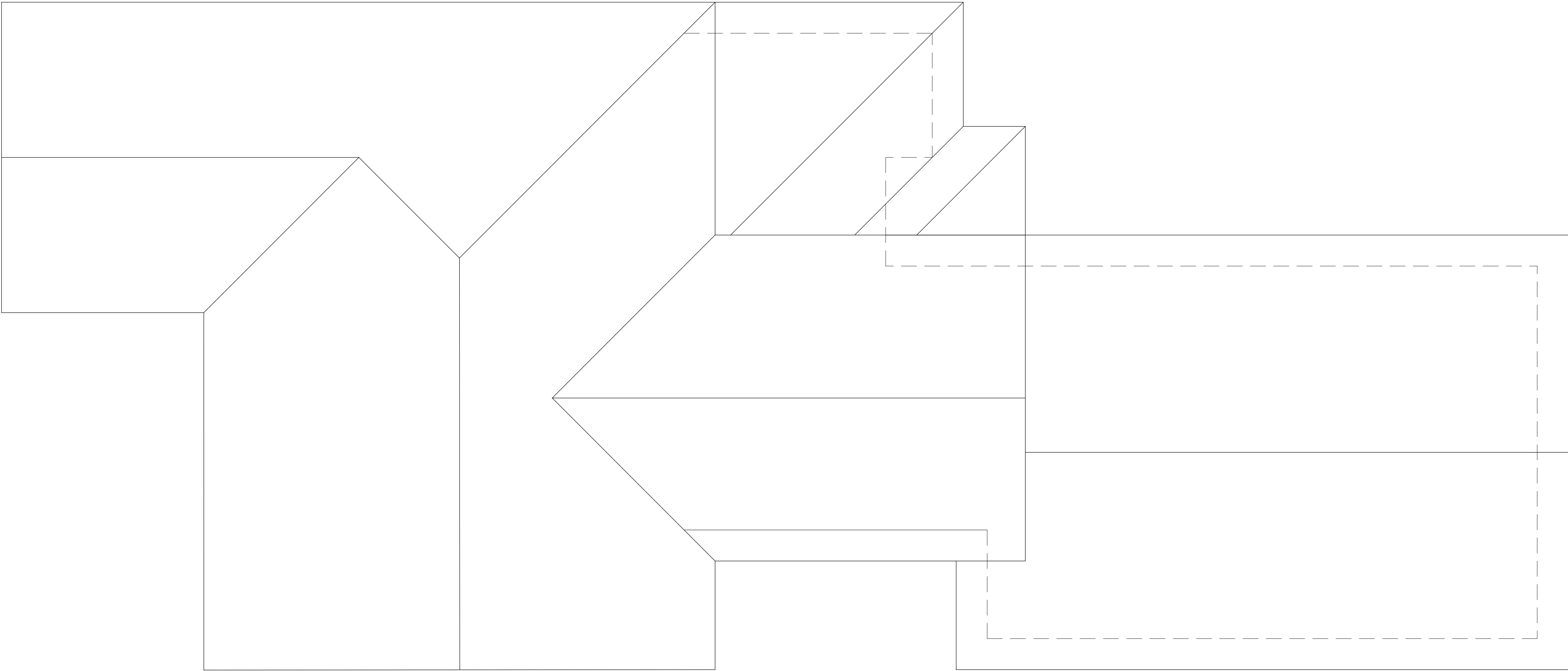

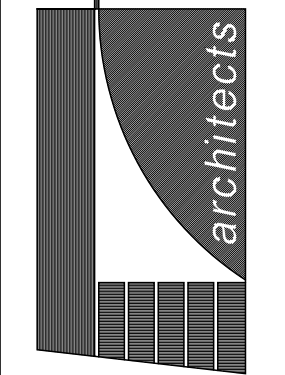


1 NORTH ELEVATION
