
SECTION - RAMP





A2 2010N - PLUMBING MEZZANINE FLOOR PLAN

A2 2010S - GROUND FLOOR PLAN SCALE: 1/8" = 1'-0"












EXTERIOR OVERALL ELEVATION - EAST



