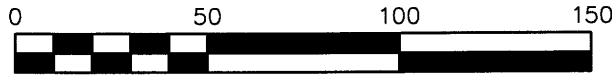


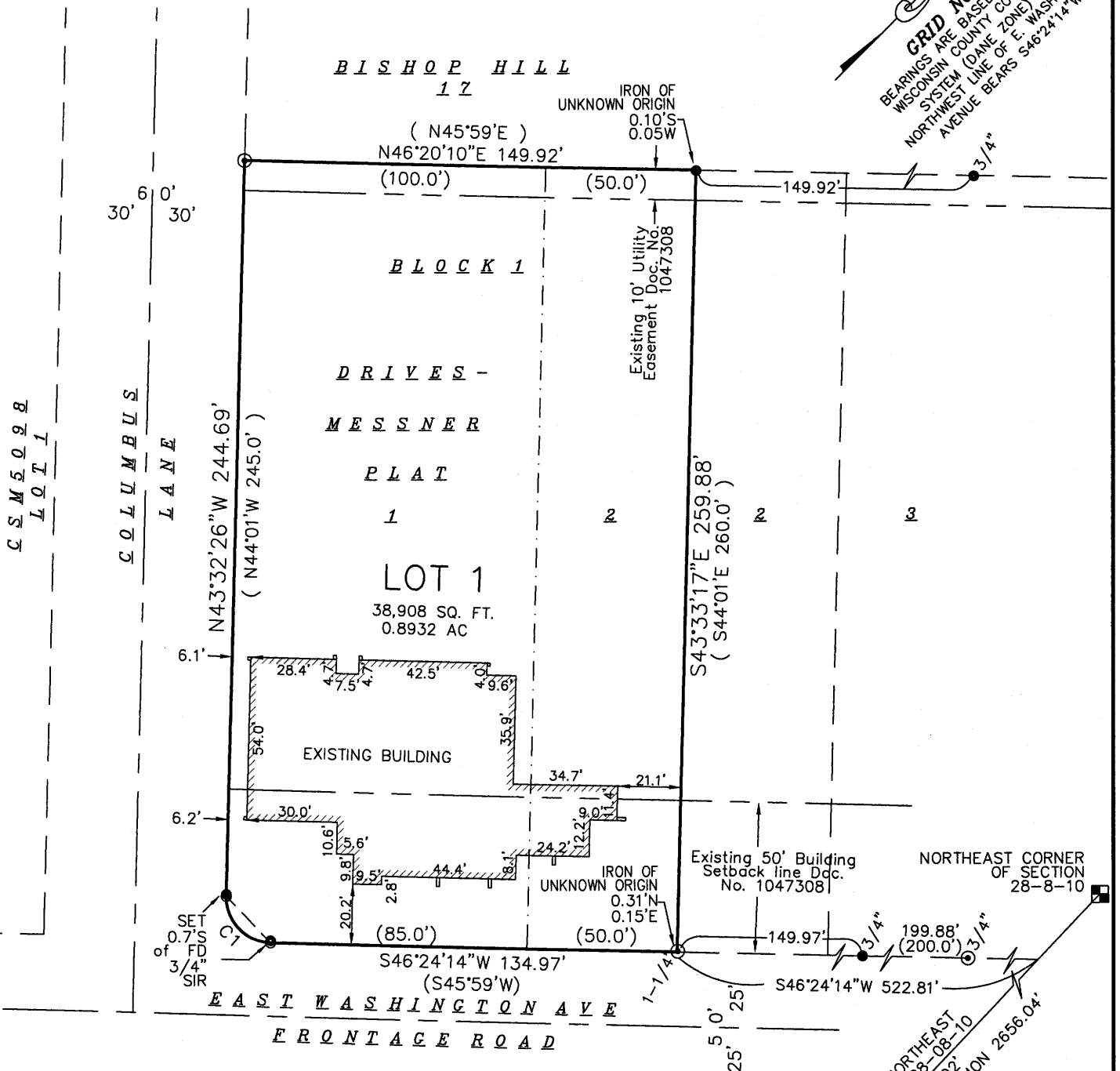

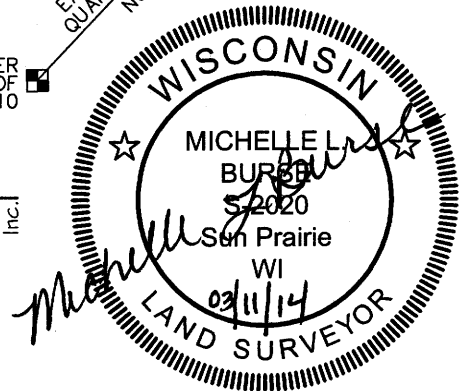

That part of Lot Two (2), Block One (1), Drives-Messner Plat, in the City of Madison, described as follows: Beginning at the South corner of said Lot 2; thence Northwesterly along lot line between Lots 1 and 2 said plat to the West corner of said Lot 2; thence Northeasterly along the Northwesterly line of said Lot 2, 50 feet; thence Southeasterly parallel to the Southwesterly line of Lot 2 to a point on the Southeasterly line of said Lot, 50 feet from the point of beginning; thence Southwesterly to the point of beginning.

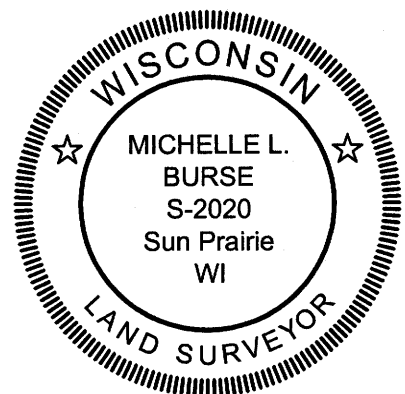
Lot 1, Block 1, and part of Lot 2, Block 1, Drives-Messner Plat as recorded Volume 25 of Plats on pages 40-41, as Document Number 1047308, being part of the Southeast 1/4 of the Northeast 1/4 of Section 28, Township 08 North, Range 10 East, in the City of Madison, Dane County, Wisconsin, more particularly described as follows: Commencing at the Southeast corner of the Northeast Quarter of said Section 28; thence North 01 degree 31 minutes 03 seconds West along the east line of said Northeast 1/4, 1192.92 feet to the northwesterly line of East Washington Avenue (Frontage Road); thence along said northwesterly line, South 46 degrees 24 minutes 14 seconds West, 522.81 feet to the point of beginning; thence continuing along said northwesterly line, South 46 degrees 24 minutes 14 seconds West, 134.97 feet to a point of curvature; thence 23.58 feet along the arc of a curve to the right, through a central angle of 90 degrees 03 minutes 20 seconds, a radius of 15.00 feet, a chord bearing North 88 degrees 34 minutes 06 seconds West and a chord length of 21.22 feet to the northeasterly line of Columbus Lane; thence along said northeasterly line, North 43 degrees 32 minutes 26 seconds West, 244.69 feet to the west corner of said Lot 1; thence along the northwesterly line of aforementioned Block 1, Drives-Messner Plat, North 46 degrees 20 minutes 10 seconds East, 149.92 feet; thence South 43 degrees 33 minutes 17 seconds East, 259.88 feet to the point of beginning. 
