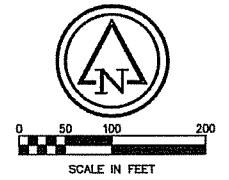

CONSTRUCTION SEQUENCE:

1. INSTALL AND MAINTAIN ALL EROSION AND SEDIMENT CONTROL MEASURES.
2. BEGIN CONSTRUCTION ACTIVITIES
 - a. REMOVE TOPSOIL AT ROOF FARM COMPLEX AND ROAD EXTENSION. PLACE GEOTEXTILE FABRIC.
 - b. CONSTRUCT ROOF FARM AGGREGATE SURFACE TO FINISH GRADE.
3. CONSTRUCT ROADWAY INCLUDING BASE COURSE AND PAVEMENT.
4. COMPLETE FINAL RESTORATION INCLUDING TOPSOIL, SEED, FERTILIZER AND MULCH.
5. REMOVE TEMPORARY EROSION CONTROL MEASURES AFTER 70% GROWTH DENSITY HAS OCCURRED IN 100% OF RESTORATION AREAS.
