EASEMENT DETAIL 2

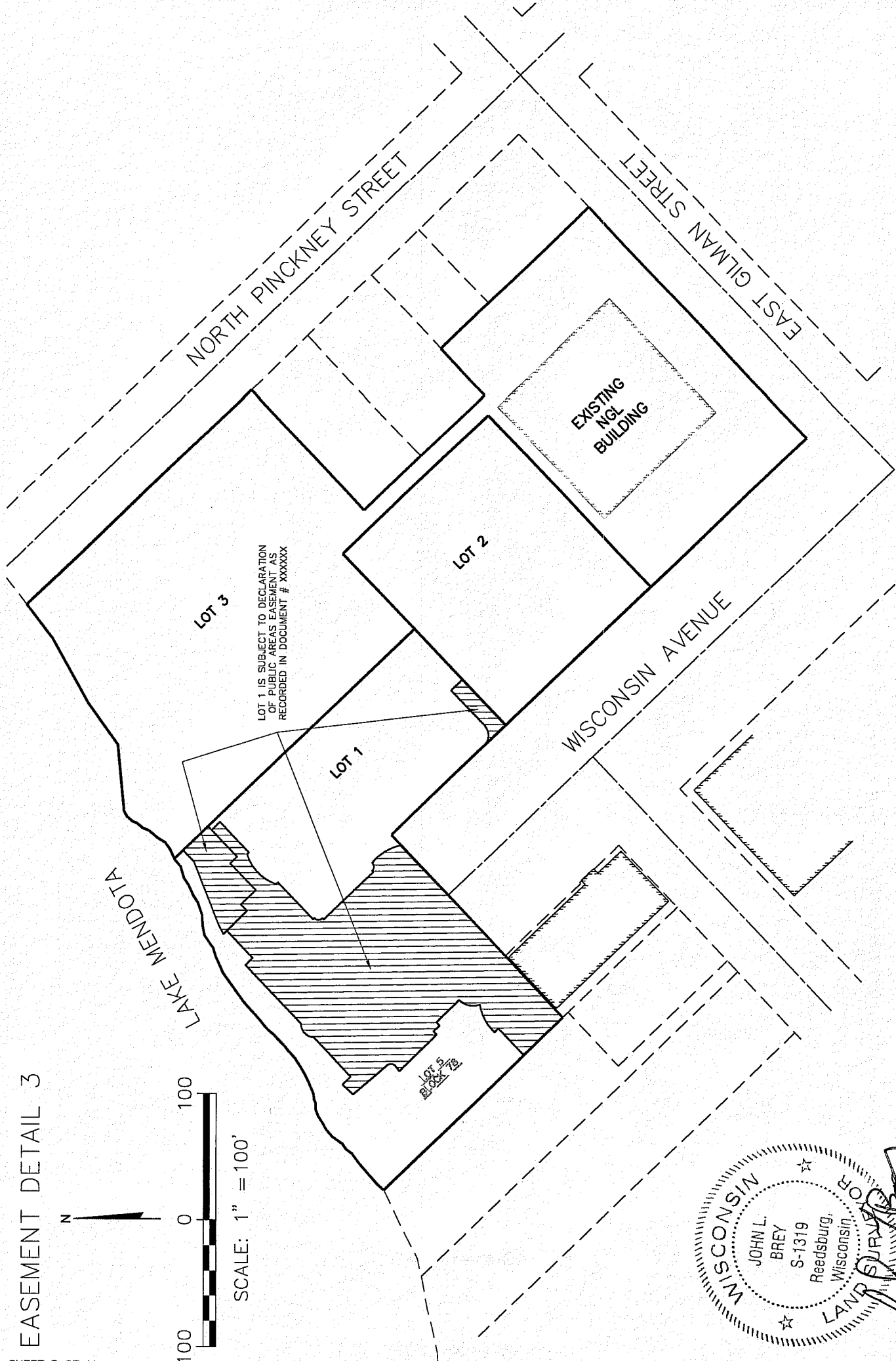

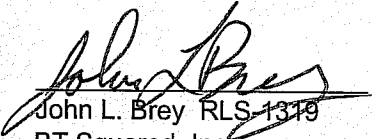
SURVEYOR'S CERTIFICATE

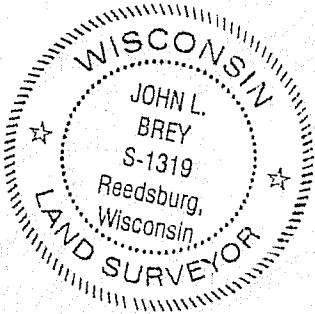
I, John L. Brey, Wisconsin Registered Land Surveyor, hereby certify that I have surveyed, divided and mapped a parcel of land located in part of Lot 5, Block 78, and Block 94, and Block 263, and the vacated Wisconsin Avenue and the vacated Langdon Street of the Original Pritchette Plat of Madison, located in Government Lots 1 and 2, Section 14, Town 7 North, Range 9 East, City of Madison, Dane County, Wisconsin, described as follows:

COMMENCING at the South Quarter Corner of Section 14, Town 7 North, Range 9 East, Thence S88°46'25"E, 1451.47 feet along the south line of the Southeast Quarter of Section 14; Thence N01°13'35"E, 1304.12 feet to the most southerly corner of Block 94, said point being the point of intersection of the Northwestern right of way line of East Gilman Street with the Northeasterly right of way line of Wisconsin Avenue; said point being the POINT OF BEGINNING; Thence N43°54'36"W, 383.60 feet along the northeasterly right of way line of Wisconsin Avenue; Thence N44°00'35"W, 72.18 feet along the northeasterly right of way line of Wisconsin Avenue; Thence S46°27'50"W, 198.43 feet; Thence N44°00'50"W, 199 feet, more or less to the shore of Lake Mendota; Thence Northeasterly, 559 feet more or less along the shore of Lake Mendota to the southwesterly right of way line of North Pinckney Street; Thence S43°54'33"E, 245 feet more or less along the southwesterly right of way line of North Pinckney Street to a point that is 293.5 feet northwesterly of the northwesterly right of way line of East Gilman Street; Thence S46°23'22"W, 130.40 feet; Thence S43°53'43"E, 132.23 feet; Thence N46°07'26"E, 50.15 feet; Thence S43°54'33"E, 162.00 feet to the northwesterly right of way line of East Gilman Street; Thence S46°02'09"W, 250.82 feet along the northwesterly right of way line of East Gilman Street to the POINT OF BEGINNING.
