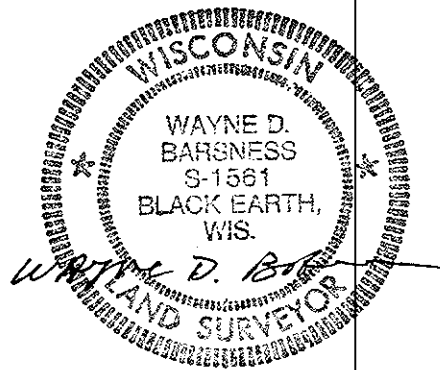
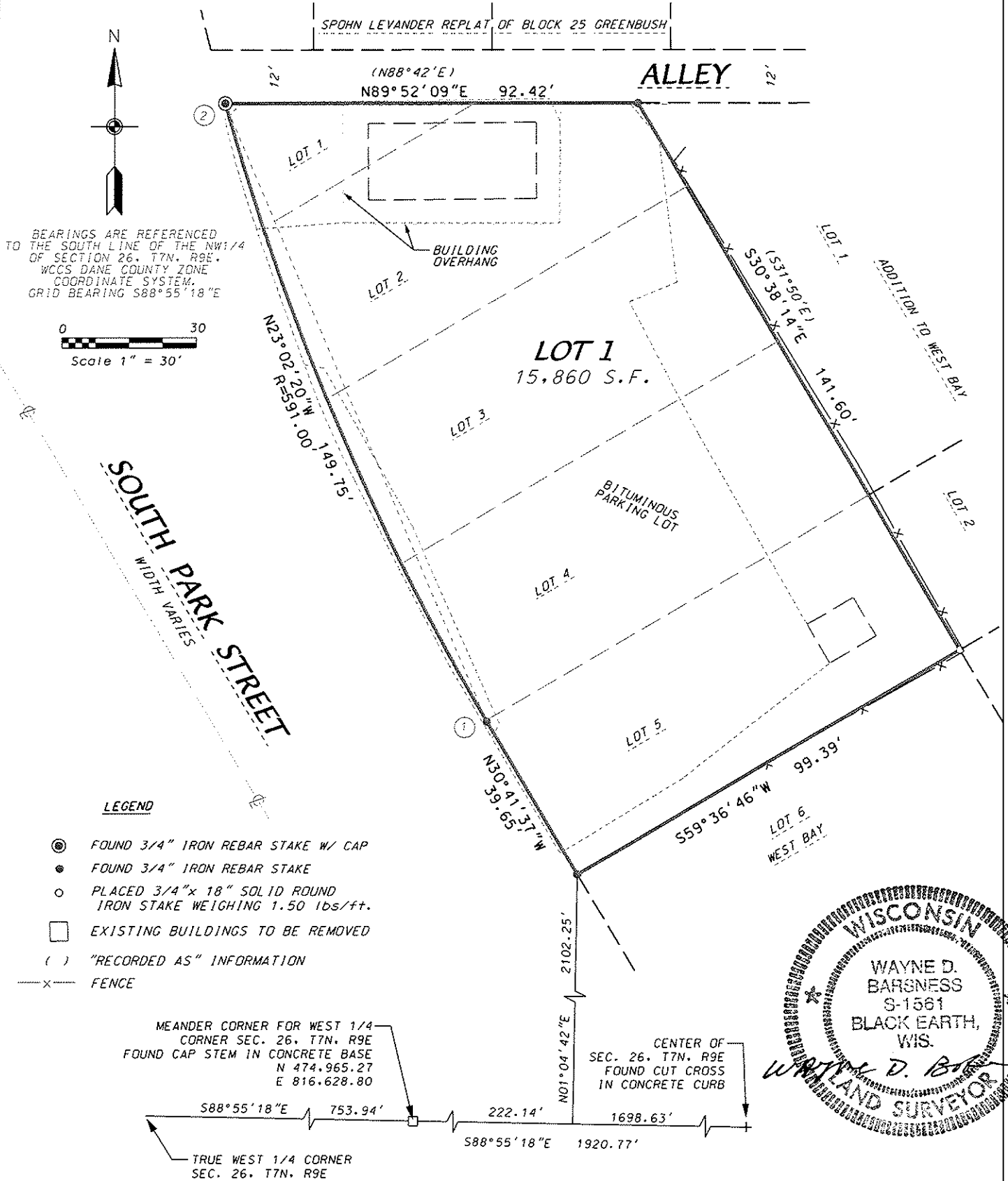


CERTIFIED SURVEY MAP

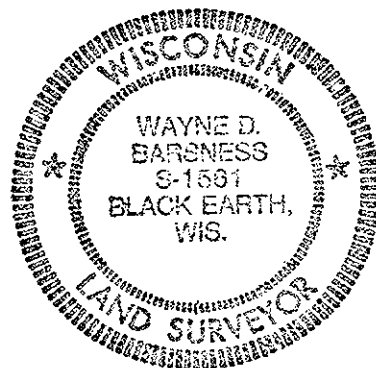
SURVEYOR'S CERTIFICATE

I, Wayne D. Barsness, Registered Land Surveyor S-1561, do hereby certify that this survey is in full compliance with Chapter 236.34 of the Wisconsin Statutes and the Subdivision Regulations of the City of Madison, Dane County, Wisconsin, and under the direction of the Owners listed below, I have surveyed, divided and mapped the land described herein and that said map is a correctly dimensioned representation of the exterior boundaries and division of the land surveyed. Said land is described as follows:

Part of lots 1, 2, 3, 4, and 5, Plat of West Bay, in the City of Madison, Dane County Wisconsin, except conveyances to the State of Wisconsin and City of Madison for right of way as document numbers 749554, 756494, 1361810, 757491, 1355952 and 749155. Located in the NW1/4 of the NW1/4 of Section 26, T7N, R9E, City of Madison, Dane County, Wisconsin to-wit: Commencing at the meander corner for the west quarter corner of said section 26; thence S88°55'18"E, 222.14 feet; thence N01°04'42"E, 2102.25 feet to the point of beginning and a point on the southwesterly right-of-way line of South Park Street; thence N30°41'37"W along said right-of-way line, 39.65 feet to a point of curve; thence northwesterly along said right-of-way line on a curve to the right which has a radius of 591.00 feet and a chord which bears N23°02'20"W, 149.75 feet to a point on the south line of a platted alley; thence N89°52'09"E along the south line of said platted alley, 92.42 feet to the most westerly corner of lot 1 Addition to West Bay; thence S30°38'14"E along the easterly line of lots 2-5 West Bay, 141.60 feet to the most easterly corner of said lot 5; thence S59°36'46"W along the southerly line of said lot 5, 99.39 feet to the point of beginning. Containing 15,860 square feet.

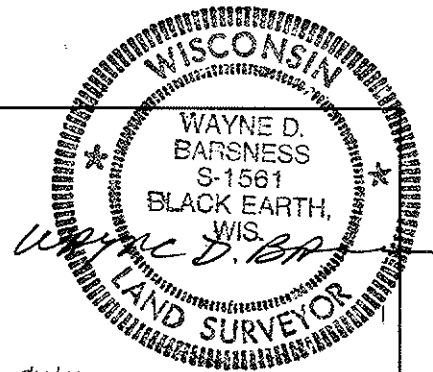

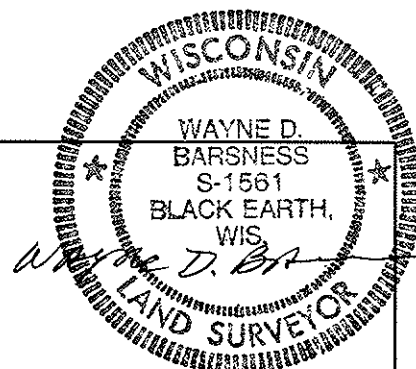
