Plan Commission members:

I am writing to oppose the demolition of the 3 buildings on Iota Ct in my district. It is important to recognize how much these buildings contribute to the character of the neighborhood and are integral to the federally registered historic district in which they are located. We have defined this neighborhood as historic for a reason. We recognize that the diversity of the construction, architecture and age of the residential buildings provide uniqueness to a small geographic area. As commissioners, it is incumbent on you keep the landmark district in mind when considering any changes in its boundary.

The character of proposed development also needs to be considered with respect to the landmark district. It is out of place here. We have developed zoning for this scale of construction east of campus between Johnson and Gorham. This proposed development will dwarf surrounding residential properties, shade residents' homes and create urban canyons amplifying the wind off Lake Mendota. Furthermore, do we really need more density in what is already the most densely populated neighborhood in the city?

Lastly, preserving the character of a neighborhood, as we are directed to do by its federally registered landmark status, is very difficult. The erosion of a building here and a building there or the construction of several buildings out of character is easy to suffer over a long period of time. But we don't want to look back in 50 years and regret having made the passive choice.
