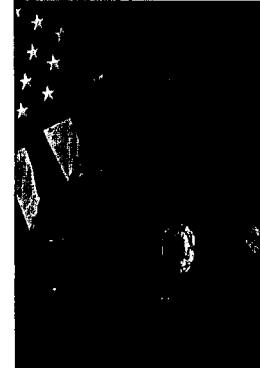

Subject: Discipline PS&IA #

The purpose of this memo is to notify you of the discipline being imposed upon you for your violation of MPD policy 2-225 Firearms Safety. The investigation into this matter has shown 05/15/2007 you accidentally left your loaded firearm in the restroom of The Manna Bakery, a business open to the public for a period of at least one hour. A citizen discovered your weapon and turned it over to Maple Bluff Police. Your actions were in violation of MPD policy.

In determining the disposition to this case we considered the following factors:

- We believe that you could reasonably be expected to have knowledge of the consequences of your conduct.
- We believe that the policy you violated is a reasonable policy.
- We believe that a reasonable effort was made to discover whether you did, in fact, violate policy.
- We believe that the investigation was both fair and objective.
- We believe that there is substantial evidence that you violated policy.
- We believe that we are applying this discipline to you fairly and without discrimination.
- We believe that this discipline reasonably relates to the seriousness of this violation and to your service record with the Department.

For violating policy 2-225 we are issuing you this letter of reprimand.

Pursuant to section 62.13 of the Wisconsin Statutes, you may ask for a review of this matter before the Madison Police and Fire Commission.

SUBJECT: **Matt Kenny**

On 5-15-07 Sgt. Rachael Peterson notified me that Officer Matt Kenny accidentally left his firearm inside a restaurant bathroom while off duty. She informed me that as the O.I.C. she received a call from Kenny advising her of the incident. Sgt. Peterson advised that the restaurant is in the Village of Maple Bluff and they responded, recovered the weapon and later returned it to Kenny.

In reviewing Maple Bluff officer Hoffman's report I learned that on 5/15/07 at 12:51 pm they responded to The Manna Bakery, 611 N. Sherman Ave. reference a gun that was found in the bathroom. Responding officers located and secured the weapon resting on a small set of shelves next to the toilet. The officer noted that the bathroom is designed for single occupancy. They state that due to the model of the weapon and the ammo they believed that weapon belonged to a Police Officer. Restaurant employees stated an unknown customer discovered the weapon in the restaurant and advised employees. Maple Bluff PD was in the process of property tagging the weapon when Kenny contacted them to retrieve his weapon. Kenny told Maple Bluff officers that he ate lunch at Manna at approx 11:30 am prior to leaving he used the restroom. Kenny advised that he removed the weapon from the holster and sat it down he left forgetting to pick it up. Kenny then went to take his dogs for a walk he then realized that his weapon was missing. He stated that he called Sgt. Peterson in the O.I.C.'s office and the Restaurant. When he called the restaurant they notified him that the weapon was located and turned over to Maple Bluff P.D. Maple Bluff P.D. returned the weapon to Kenny. They state that he was apologetic for his oversight and for the inconvenience he caused.

Possible Policy Violation: 225 - FIREARMS SAFETY

Members of the department shall strictly adhere to all safety guidelines when handling any firearm to prevent an unintentional discharge of that firearm. Members shall not engage in any behavior with a firearm that may pose an unnecessary danger to any other person. This policy applies to all members of the department while on duty and to the handling of any department approved weapon while off duty.

INTERVIEW WITH OFFICER KENNY

On June 25, 2007 I notified Kenny I wished to interview him regarding this incident. He was advised that he could have a union representative present if he wished. This notice was delivered via telephone and in writing. This interview took place on June 28, 2007 in my office Kenny was with P.O. Scott Favour. I asked Kenny to tell me what happened on May, 15 in reference to his firearm. Kenny stated the following: He went for lunch at the Monna Cafe on North Sherman for approx. 1 to 1/1/2 hour. He was on his day off and stated that he was carrying his off duty firearm, which is a Glock model 27. Kenny states he usually carries his firearm when off duty. Kenny stated he used the rest room, which he describes as one room with one toilet and sink. He had his firearm in his holster, when he used the toilet he placed it on the floor next to the toilet. He states when he finished using the toilet he left to continue his day, which included taking his dogs for a walk in the country. The walk lasted for about an hour, he estimates it was approximate 1 ½ to 2 hours from the time he left The Monna. When he returned to his truck from the dog walk he notices that his firearm is missing from the holster. At first he thought he lost it in the woods. Then he recalls using the bathroom at Monna's and placing it on the floor. He states he immediately called the O.I.C. and spoke with Sgt. Grady. He asked Sgt Grady if there was any CFS regarding a firearm being located at Monna's Both Kenny and Grady are thinking Monna's is in the City of Madison. Sgt Grady states that there had been no calls at Monna's. Sgt. Grady advises Kenny to search for the firearm and if he can't find it to call back. Kenny goes directly back to Monna's and asks their staff if anyone discovered a firearm on the premise. Kenny was told yes and was advised that they turned it over to Maple Bluff Police. Kenny states he left his business card with their staff and drives to Maple Bluff P.D. At Maple Bluff P.D. he speaks with Sgt. Ann Murphy who acknowledges they were called to Monna's reference a firearm being found in the bathroom. Sgt. Murphy returns the firearm to Kenny. Kenny checks the magazine and verifies that all rounds are still present. Kenny states he was extremely embarrassed with discussing this with Sgt. Murphy and with his irresponsibility. After recovering his firearm Kenny states he recalled the O.I.C. and speaks with Sgt. Peterson. He explained to her what had occurred and provided her with Maple Bluff's case number. Kenny ended our interview stating that he is extremely embarrassed over this and is extremely grateful in what Monna's did and very relieved that his weapon wasn't stolen or used in a criminal manner.

Summary:

On 07/15/07 at 6:12 PM Officers Diane Nachtigal and Matt Kenny were dispatched to 5001 Camden Rd. reference a man armed with a gun on the front porch of that address. Dispatch provided responding officers with a description of this armed suspect and advised that he had threatened neighbors while armed. The suspect was later identified as Ronald A. Brandon.

Officer Nachtigal was the first officer on scene and upon her arrival Brandon was seated in a chair on the front stoop of the residence holding what appeared to be a revolver type handgun in his hand. Officer Nachtigal exited her squad, drew her service weapon, took up a position of cover and began to verbally engage Brandon from a distance. Moments after her arrival, Officer Nachtigal notified dispatch that the suspect had pointed the gun in her direction. Shortly thereafter, Officer Kenny arrived on scene. Officer Kenny deployed the AR-15 rifle from his assigned marked squad and upon exiting his squad he joined Officer Nachtigal in issuing repeated verbal commands to Brandon to drop his weapon. Brandon refused to comply and at one point he stood up from his seated position, turned toward Officer Kenny, and pointed the handgun toward Officer Kenny. Officer Kenny immediately fired two rounds from the AR-15 rifle mortally wounding Brandon.

Subsequent investigation revealed that the handgun Brandon had in his possession was, in fact, a facsimile weapon and that Brandon himself had placed the initial call to dispatch to report a subject armed with a gun in front of 5001 Camden Rd. and provided dispatch with a description of himself. Investigation further showed that Brandon drinking alcohol throughout the day of this incident. Prior to arming himself with the facsimile weapon and calling dispatch to report an armed subject (himself), Brandon made the statement to his ex-wife that "this was going to end." He seated himself on the front stoop, weapon in hand, and awaited police arrival.

Disposition:

This incident was reviewed for compliance with Madison Police Department Policy 6-100:

Deadly Force Authorized

The use of deadly force is only authorized when, under any of the following circumstances, an officer reasonably believes a lesser degree of force would be insufficient:

1. In the defense of another person who the officer has reasonable cause to believe is in imminent danger of death or great bodily harm;
2. In defense of one's self, when there is reasonable cause to believe one is in imminent danger of death or great bodily harm;
3. To effect the arrest or prevent the escape of a suspect who the officer has reasonable cause to believe has committed, or attempted to commit, a felony involving the use or threatened use of deadly force, when a high probability exists that the suspect, if not immediately apprehended, may cause death or great bodily harm;
4. To protect one's self or another from an animal which an officer reasonably believes may cause great bodily harm if not immediately controlled, or to end the suffering of an animal gravely injured or diseased after considering public view, safety, and other reasonable dispositions.

The review showed that the actions taken by Officers Nachtigal and Kenny were reasonable, appropriate, and well within the MPD policy, procedure, and training.

Summary:

1865 - 1876

On 11/27/14 PO Kneubuhler, PO Marzullo, PO Buccellato and I responded to a residential burglary in progress. As we were arrived on scene PO Alan and PO Woehrle took the initiative to respond to the area just in case they were needed. PO Marzullo and PO Buccellato went to the back of the residence as PO Kneubuhler and I approached the front. PO Marzullo called out he had two suspects fleeing out of the backyard. The suspects separated and PO Marzullo and PO Buccellao continued after one of them. PO Woehrle who was mobile assisted and converged on the suspect. While using good officer safety, PO Woehrle contacted the suspect at gun point just as the suspect was reaching over another fence. PO Woehrle and PO Buccellato got the suspect on the ground and took him into custody. This suspect was in possession of some stolen items from the residence as well as burglary tools. This suspect matched the description of one we investigated approximately 1 week earlier where a green SUV was involved. We responded back to the residence and located the green SUV parked in front. PO Corcoran, PO Marzullo and PO Buccellato conducted a K9 track for the second suspect while PO Kneubuhler and I cleared the residence and PO Pailing canvassed the area for other possible victims. PO Kneubuhler did a good job working with the victim to identify what was stolen. PO Corcoran conducted a sniff of the suspect vehicle and got a positive alert. PO Alan and PO Marzullo searched the vehicle and located some 357 magnum ammunition as well as a purse for a female that coincided with the owner of vehicle. PO Alan then followed the vehicle to the VIF where it was impounded. PO Buccellato, PO Corcoran and her K9 partner slim conducted an article search along the path of the foot pursuit. They located some clothing dropped by the suspect as well as a fully loaded .357 magnum revolver that was on top of the wooden fence where PO Woehrle confronted the suspect. While this was taking place dispatchers Miranda Galvin and Amanda Kostroski advised they just took a call from a resident nearby who was reporting they gave a ride to a female that was out of breath and covered in pine needles. Galvin and Kostroski did a great job putting this together and getting us the information. PO Drescher and PO Pailing made contact with that resident who said her husband had not returned yet after giving the female a ride. PO Drescher learned the female used the house phone and did an outstanding job of figuring out what number was called. PO Drescher was able to call the number and eventually spoke with the female who confessed to being in the area with our arrested subject at the time of the burglary. PO Matt Kenny then responded to where the female was at and arrested her. PO Kenny observed the female was still covered in pine needles and had snow on her coat. He also relayed a description of her shoes which matched the shoe impressions in the yard. Investigator Hornung responded and processed the scene which included dusting for prints and taking photos of the suspects, the vehicle, shoe impressions in the snow, pry marks in the door, the firearm and other evidence. Both suspects were taken back to WPD where PO Kneubuhler and PO Alan completed an outstanding interview of the female who confessed to her part in the burglary. PO Kneubuhler and PO Alan also gained information about the firearm the male tried to discard and that he carries it on the burglaries in case he is confronted by a resident. The female also indicated it was stolen in a previous burglary. PO Kneubuhler and PO Alan continued to question the female who implicated the male in approximately 20 other burglaries over the past couple of months. They also learned the whereabouts of some of the stolen property including firearms, jewelry and a safe. They also obtained the name of another suspect who usually accompanied the main suspect. PO Marzullo searched the MPD police records and found the burglary where the 357 magnum was stolen as well as a safe, jewelry and \$7000. He also located 2 additional burglaries the female provided details on that had occurred in the past week. After the interviews were conducted PO Palmer and PO Spade transported the suspects to the PSB where they collected additional evidence from them. The male was charged burglary while armed, felon in possession of a firearm, possession of burglarious tools, 2 counts of felony bail jumping, criminal damage to property, resisting and 2 felony warrants. The female was charged with PTAC armed burglary. The collective effort of these Officers and dispatchers is a text book example of what it means to work as a team. The actions of these Officers and dispatchers led to the arrest of a very dangerous armed individual that had burglarized and traumatized several residents in the City of Madison and their efforts should be commended.

Summary:

1877-1889

On 11-26-14 Officers were dispatched to 1003 N Gammon Rd reference an armed robbery of the Klinky Cleaners. The suspect matched the description of an individual involved in four other commercial robberies in the City of Madison. Detective Grann had been assigned to some of the previous robberies and did an outstanding job of identifying possible suspects. Through his investigative efforts he was able to get a court order for a GPS device to be put on the suspect's vehicle. Det Grann shared the information about the suspects and their vehicle with the patrol officers and provided Lt Schwartz with access to the software so she could track the suspects if we had a similar robbery. On 11-26-14 after the airing of the robbery Lt Schwartz immediately began tracking the suspects on the GPS software and noted they were in the vicinity of the robbery. She did an excellent job of relaying information about the location of the suspects to responding units who converged in on them. PO Wipperfurth intercepted the vehicle on University Ave near Blackhawk Ave. PO Wipperfurth used good officer safety and tactics to follow the vehicle without being detected until other units could catch up with him. PO Wipperfurth did an outstanding job of picking the location for the stop to limit the possible escape of the occupants if they tried to flee on foot. PO Alan, PO Kenny, PO Creech, PO Shawn Kelly, PO Corcoran, and I assist with the high risk traffic stop while PO Love and other officers shut down traffic. Both occupants were safely taken into custody without incident. PO Kenny, PO Mackessey and PO Alan searched the vehicle and located the proceeds from the robbery, the clothing worn during the robbery and the firearm used to commit it. In addition they located several items related to drug use. Sgt Gary responded to the original scene of the robbery and coordinated the investigative efforts from there. He relayed key information to the officers at the stop about clothing worn by the suspect and currency stolen. Officer Corcoran and Officer Wilson assisted at the robbery scene with K9 tracks. Investigator Hornung responded and process the vehicle which was then towed to the vehicle impound facility and secured by PO Cherne. PO Wipperfurth and PO Alan transported the suspects to the CCB with PO Kenny and PO Kelly following. PO Mackessey identified key pieces of evidence in the vehicle which he then collected and subsequently property tagged. After the suspects were taken to the CCB Detective Grann did an extraordinary job interviewing both suspects who subsequently confessed to all five robberies. The professionalism, quick response, thoroughness and attention to detail of this group lead to the arrest of two suspects, the collection of key evidence and ultimately the confessions from both suspects. The collective effort of the Lieutenant, Sergeant, Detective, Investigator and officers led to the arrest of two individuals and put an end to a string of robberies that were traumatizing members of the community and their efforts should be commended.



Synopsis: Pre Service Rifle Training

With a recruit class of 35 students it has been no easy task to coordinate trainings for the Academy. This year training instructors have had to rely more on adjunct instructors as well as Patrol Officers willing to step up to the challenge of instructing recruits. I was tasked with gathering instructors for recruit rifle training. All training instructors were being utilized in EVOC training so all rifle instructors had to come from outside of the Training Department. All instructors came from the tactical platoons on the SWAT team to include, Entry, Scouts, and Snipers.

The instructors spent 6 days (3 days per platoon) teaching recruits and assisting other firearms instructors in adverse weather conditions to include rain, wind and below freezing temperatures at the Dane County Law Enforcement Training Center. The instruction topics to the recruits included but were not limited to; basic rifle marksmanship, shooting fundamentals, distance rifle shooting, positional rifle shooting, distance handgun shooting, basic marksmanship, firearms safety, one hand handgun manipulation, rifle manipulation, rifle malfunction clearing, rifle to handgun transitions, zeroing, multiple target engagement with rifle, movement with rifle, live fire bounding drills, live fire officer down rescue, target specific directed fire, and rifle maintenance and cleaning.

Given their various backgrounds instructors were able to give the recruits a wide range of knowledge on the use of the patrol rifle.

All instructors came with professional attitudes, appearance, and a sincere willingness to teach. Their professionalism reflects great credit upon themselves as MPD Officers, MPD SWAT, as well as the City of Madison Police Department.

The training team would like to thank the instructors for their time and knowledge as it greatly assisted the training team.



Synopsis:

On 9/9/13 MPD officers responded to [redacted] Berwyn Drive in an attempt to arrest Steven Boyle. Boyle was wanted on a probation warrant, and had recently made threats to shoot an MPD officer and a neighbor. Boyle had indicated to his family that he had acquired a gun, and that he had a specific plan to carry out his threats.

Boyle has an extensive criminal history, and has been causing problems in his neighborhood for years. He had recently been released from prison (on 7/31/13), and the prison had contacted one of

Boyle's neighbors prior to the release to warn him about Boyle making threats to injure him. Boyle also has a long history of fleeing and resisting officers.

Sgt. Paulson coordinated an initial response and attempt to arrest Boyle. A female exited the residence, and eventually admitted that Boyle was inside. SWAT personnel responded to assist, and a lengthy standoff took place.

Boyle was largely non-communicative during the incident, and refused to comply with any directions provided him by officers. The layout of the residence and yard made it challenging for officers to maintain a perimeter. Extremely hot weather also created additional challenges for MPD personnel at the scene.

Chemical agents were eventually introduced into the residence, but they did not succeed in forcing Boyle to exit. SWAT personnel then entered the residence, with the assistance of a robot and K9 Off. Felt and his partner Gildon. As the entry team cleared the residence, it became clear that Boyle was in the basement. He actually threw several items up the stairs at officers, before retreating into a small room in the basement. Boyle attempted to prevent officers from breaching the door, but was unable to. A taser deployment was attempted through the door, but was unsuccessful. Gildon was deployed into the room, and SWAT officers followed. Boyle violently resisted, attempting to choke Gildon, and striking out at officers. After a confrontation, Boyle was subdued and taken into custody. Several SWAT officers sustained minor injuries and significant exposures during the altercation.

Numerous MPD personnel assisted in the aftermath of the incident, guarding Boyle at the hospital, maintaining security at the residence, obtaining and executing a search warrant at the residence, etc.

Detectives Ludden and Harris coordinated the search warrant and criminal investigation, and submitting the case (with multiple felony charges) to the DA's office. Det. McCoy and Det. Monroe assisted with the significant exposure process, obtaining Boyle's consent to have his blood tested.

Multiple residents of the area have expressed their appreciation to the officers involved in this incident for removing Boyle from the community and allowing them to feel at ease in their homes. The Dept. of Corrections has committed to pursuing a revocation of Boyle's probation, and the District Attorney's office has committed to a vigorous prosecution of Boyle, seeking prison time.

Boyle is clearly a dangerous individual who does not belong in the community. It took an extraordinary effort on the part of many MPD employees to safely apprehend him, and they should all be recognized for their efforts.



I understand that Wisconsin State Statute 103.13 clearly articulates exceptions related to employee access of their Personnel records. Those exceptions are:

- Records relating to the investigation of possible criminal offenses committed by that employee.
- Letters of reference for that employee.
- Any portion of a test document, except that the employee may see a cumulative total test score for either a section of the test document or for the entire test document.
- Materials used by the employer for staff management planning, including judgments or recommendations concerning future salary increases and other wage treatments, management bonus plans, promotions and job assignment or other comments or ratings used for the employer's planning purposes.
- Information of a personal nature about a person other than the employee if disclosure of the information would constitute a clearly unwarranted invasion of the other person's privacy.
- An employer who does not maintain any personnel records.
- Records relevant to any other pending claim between the employer and the employee, which may be discovered in a judicial proceeding.
- Copies. The right of the employee or the employee's representative to inspect records includes the right to copy or receive a copy of records. The employer may charge a reasonable fee for providing copies of records, which may not exceed the actual cost of reproduction.

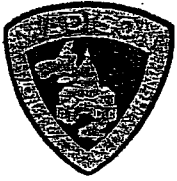

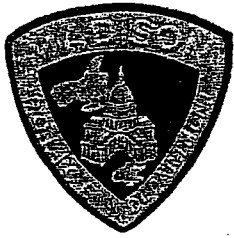

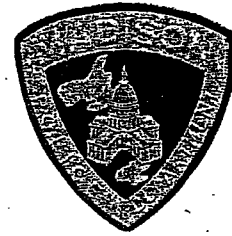

In February of 2010, I contacted Sgt McClurg and requested that he and other SWAT members assist with the planning and instruction of a one day training for all CPT members and NPO's.

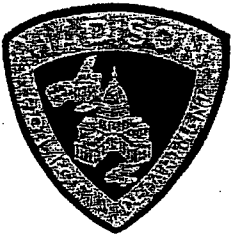

The department had an inventory of 182 rifles, which was far short of the number needed to allow all commission personnel to be issued a rifle. The management team approved the purchase of rifles by individual officers.

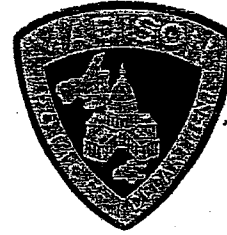
The Individual Rifle Purchase Planning Committee was formed and members included Joel Plant from the Mayor's Office, Deb Simon from the Comptroller's Office, Lt Patterson, Det Austin, PO Harder, PO Patton, and myself. This committee did a number of tasks: 1) conducted a survey of the department to see what level of interest there would be in staff purchasing rifles, 2) set-up a rifle purchasing process that would allow the officers to pay for the rifles over a two year period using payroll deduction, 3) wrote a resolution to the City Coucil, 4) walking the plan through a number of committees, and 5) final passing of the resolution to authorize individual rifle purchase.

After the resolution passed authorizing individual rifle purchases, the Individual Rifle Purchase Implementation Team was formed (October 2009) with the following members; Lt Patterson, Sgt Schmidt, Sgt Rife, Sgt Fiore, Det Austin, PO Harder, PO Patton, PO Kenny, PO Alan, PO Berkovitz and myself. This committee was responsible for the researching of rifles, rifle cases and locks, rifle slings, rifle storage units, and rifle policies. Committee members obtained bids and placed orders for 215 rifles, night sights, cases, and slings. District armories needed major

On 6/29/09 Caleb Bedford took a domestic call on the west side. Caleb developed pc for domestic charges and had credible information that the suspect, a convicted felon on probation for persons crimes, had threatened and displayed a hand gun.

Caleb quickly aired the suspect, weapon, and vehicle information, advising he had pc for the suspect and pc to search the trunk--the believed location of the firearm.

At approximately 1424, Matt Kenney alertly spotted the suspect vehicle outbound on E Washington Ave near North St. He aired the information and followed it until additional units were available to execute the high risk stop. Matt was articulate and clear over the radio, and responding units knew exactly where he was at all times.

Shawn Kelley was the first officer to get behind Matt, and the two initiated a high risk stop. Additional patrol, NCPT, and neighborhood units arrived to assist, taking both the suspect and the passenger into custody and blocking off traffic on outbound E Washington Ave. Both occupants were detained without incident. The vehicle was subsequently cleared and a .22 cal semi-automatic Ruger handgun was located along with a magazine containing approximately 6 rounds of ammunition.

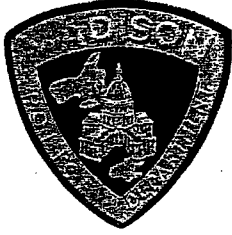
Jason Salerno from the ATF arrived to assist with the investigation. In addition to domestic charges, the suspect is looking at possibly 25 years in prison for felon-in-possession charges.

This incident was handled effectively and efficiently, resulting in the safe capture of a violent suspect and seizure of a firearm. Excellent team work and communication was displayed by all involved.

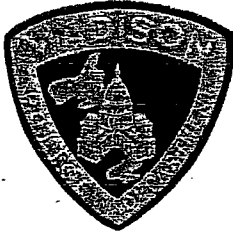
Synopsis:

Due to the complex nature of the call, and as resources were thin, I realized that I would not be able assist those officers in a peer support capacity. It was past midnight when I placed a call to PO Matt Kenny for help. Although woken up from his sleep, PO Kenny quickly volunteered to respond in order to help. PO Kenny arrived on scene within 20 minutes and immediately offered his assistance as a Peer Support Officer. While on scene, he conducted a "check-in" with each of the responding officers involved, assisted in contacting and briefing the EAP coordinator, and assessed the need for additional CISM and peer support resources. PO Kenny's actions that day are an example of his on-going care and dedication to his fellow co-workers and underline the crucial need for peer support during critical incidents.

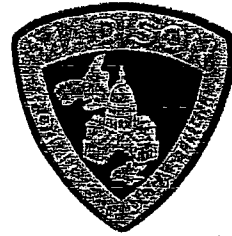

On 03-07-09, a call came in to dispatch from the parents of a suicidal male, [REDACTED] who had armed himself with a knife and an axe in the attic of [REDACTED] E. Dayton St. The arriving officers quickly established a perimeter and Sgt. Donahue was directing the scene. Det. Buechner was listening to the radio and responded immediately from north district. Officers Dzick and Kenny were positioned at the rear of the residence, Officer Prohaska was on the west side of the residence, and Officers Eull, Smith and Meylor were on the front porch. Det. Buechner spoke with [REDACTED] parents and Officer Penly spoke to his girlfriend. As officers held the perimeter, Sgt. Donahue began negotiations over the phone with [REDACTED]

As negotiations continued, the I monitored the perimeter. At approximately 5:26pm, officers on the front porch began shouting at [REDACTED] who had come onto the landing outside of his 2nd floor residence holding an axe with a 4' handle in both hands. As he squared off to the officers, yelling at them to get off of his property, PO Nick Eull fired one less lethal round at [REDACTED] striking him on the right side of his chest on the lower edge of his rib cage. [REDACTED] never dropped the axe, but he doubled over and crawled back into his residence.

PO Kip Kellogg arrived to continue negotiations. North district command staff and Lt. Woodmansee arrived to help monitor the scene. Eventually, PO Kellogg convinced [REDACTED] to come out the front door of his residence with empty hands so officers could contact him. At approximately 6:17pm, [REDACTED] did exit his residence and was taken into custody without further incident by Officers Smith, Eull and Meylor. [REDACTED] and his parents later expressed

Sgt Kelly Donahue and the above personnel responded to [REDACTED] E Dayton St ref a suicidal subject, armed with an axe. The suspect barricaded himself and refused to come out. Sgt Krueger Favour responded to coordinate the perimeter, so that Donahue could focus on negotiating with the suspect. Other Crisis Negotiators (Kellogg and Lt Woodmansee) responded and Kellogg took over the negotiations. At one point, the suspect exited the house, approaching officers with an axe in a threatening manner from short distances. PO Eull used a Less Lethal shotgun to stop the suspects approach, and the suspect retreated back into the house. Ultimately, the suspect was persuaded to exit the home. Suspect was taken into custody and place in protective custody.

I spoke the subject's father and mother at the scene. They said that they were very grateful for the highly professional and compassionate way the officers handled the entire situation. I was extremely impressed with the manner in which all personnel responded, and with the post incident scene management by Sergeants Donahue and Krueger Favor as well.

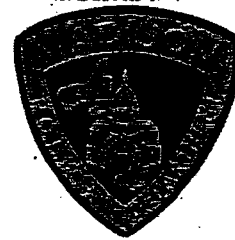
The effective police response doubtless saved this suspect's life. The above personnel deserve to be commended for their efforts in this challenging case.

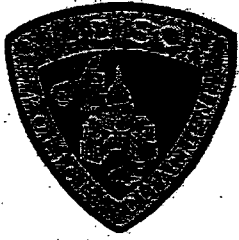

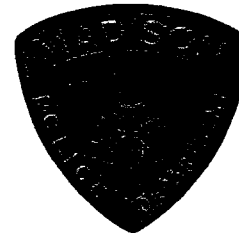
Dispatch toned out a home invasion at [redacted] Debs Lane on the far north side. The roads were near impassable in areas due to the snowstorm that had been an issue most of the day. Officer Scott Sachtjen got to the area first as dispatch was indicating they had received a call from a woman arriving home to find forced entry and two men in her house. She saw the men take off and was able to get a rough description. Officer Sachtjen spotted the suspects and started a foot pursuit. He lost sight of the suspects but noted the trail they were leaving. Officers Ware and Eull were next on scene and officers located the likely tracks of the suspects as they continued to flee. Other officers were able to respond in and set up a perimeter. Officer Wilson and his K-9 partner Ivan started a track with officers able to provide a shifting perimeter as the track continued. Finally the suspects were tracked directly into a 4 unit apartment building. Officer Sachtjen spotted one of the suspects through a window and initiated contact. Ultimately both suspects were taken into custody safely and good evidence recovered. Very nice job by human and canine officers in terms of perseverance and dedication in difficult conditions.

Synopsis:

Officers were dispatched to a report of an older, terminally ill man, possibly delusional, seeing non-existent intruders in his apartment and firing off rounds at these delusions. The couple living downstairs from this man fled their home and called 911. The officers listed above responded to this call and were all instrumental in bringing it to a safe conclusion.

Officers Kenny, Bramlett, Hull, Mosley, Martens and Pharo were first responders, immediately shutting down traffic and setting up an effective inner perimeter. Officer Martens was handed the complainants and got vital information for us while also shutting down traffic. Officers Orvis and Finnegan and Sgt. McCaw responded in and reinforced the perimeter.

Officer O'Shea assisted on the inner perimeter and, using his phenomenal ability to project his voice, successfully made verbal contact with the suspect. The suspect rushed out of the two-flat house with a loaded semi-automatic handgun in hand towards the perimeter officers. Several officers were a heartbeat away from firing at the suspect when they realized the suspect was flinging the gun into a snowbank. He was successfully taken into custody.

Officers Van Domelen took over the investigation and transported the suspect to UW ER to initiate an Emergency Detention. Officer Bauman assisted her.

Officer Crose assisted with holding the scene and evidence. Inv. McEvoy processed the scene and assisted with evidence.

This was an extremely dangerous incident. The suspect posed an immediate threat to everyone in this residential neighborhood. He had fired numerous rounds inside his apartment, some traveling outside his residence and out into the neighborhood. He had two handguns and many rounds of ammunition remaining. It turned out that not only did the suspect suffer from many illnesses, he also admitted to using cocaine earlier in the day with friends. Only the training, expertise and judgement of the officers on the perimeter kept this from becoming an officer involved shooting. Teamwork kept everyone alive and resolved the situation safely.

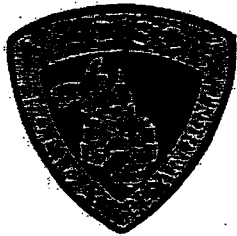

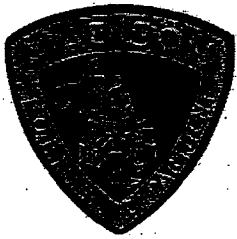
Synopsis:

Not immediately successful, they noticed a vehicle approaching and Officer Kenny recognized the back seat passenger as the suspect he had seen on a surveillance tape. When the car pulled up, the officers took the suspect into custody amidst much family drama. In the ensuing chaos, one adult placed an infant and a 4 year old in the car which had been left parked in the driveway. Shortly after the children were placed in the car and while the officers were still dealing with all the family drama, the officers realized the car was now rolling down the driveway and toward the road. Both officers immediately tried to slow the movement of the rolling car by physically pushing against the car, fighting gravity. Officer Ramirez, realizing this was not working, got to the passenger side door, opened it and got to the brake, halting the vehicle. Apparently the 4 year old, still laughing, had somehow bumped the car into gear while jumping between the front and back seats. Both children were unharmed. While there is not often heavy traffic on this street, cars often speed around the curves and use this area as a short cut. The quick thinking and actions of these officers kept this situation from a more serious outcome. They should be commended for their rescue of the children under trying circumstances.

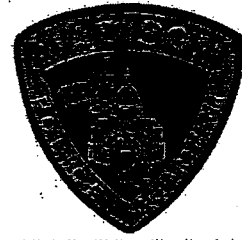

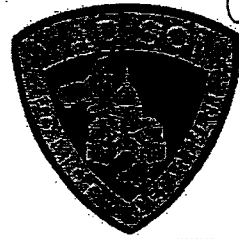
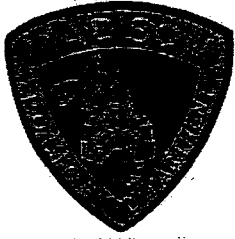
Synopsis:

He arrived ahead of Fire and found the victim down in a bed upstairs in the home. He had to deal with very upset family members, but was still able to successfully pull the victim off the bed onto the hardwood floor, attach the AED pads, assess, and begin CPR. When paramedics arrived, they determined the victim was beyond resuscitation and could not be saved. Officer Kenny then turned his attention to the death investigation and controlling the scene. The MFD personnel on the scene later commented that they were very impressed with Officer Kenny's competence, preparation and professionalism. 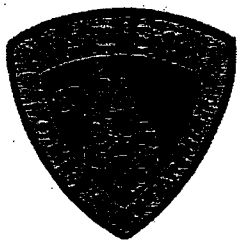
Synopsis:

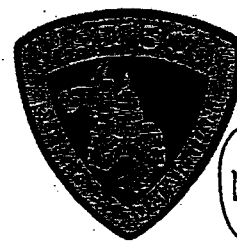

Synopsis:

Union Cab driver [redacted] repeatedly hit her emergency button as she was being robbed and car jacked at gunpoint. One suspect held a knife to her throat in the cab and the other pointed a gun at her. She still had the presence of mind to hit the emergency button which allowed her own dispatcher to give us GPS information as to her whereabouts as we responded in to the area. Officers Lindsey and Mackesey were closest and spotted the cab as the driver was being forced to attempt an ATM withdrawl. The suspects subsequently spotted the squad car, forced the victim to drive, then bailed out of the moving cab, fleeing on foot. Complicating matters [redacted] understandably extremely frightened, took off at a high rate of speeding causing us initial concern that she was still under duress.

As the incident continued to unfold, Officers Lindsey and Mackesey attempted to relocate the suspects. They assisted Capitol PD Officer Drogsvold with a foot chase in the area. Officers Matt Kenny and Alex Mayerhofer spotted two possible suspects leaving the area in a car. Officer Henry Wilson initiated the car stop. Sgt. Krueger Favour coordinated a response to a bus uptown after a citizen indicated one of the suspects likely boarded that bus. Other officers held a

perimeter for a track and article search. Det. Joel Peterson responded to assist and Inv. Mueller assisted with evidence.

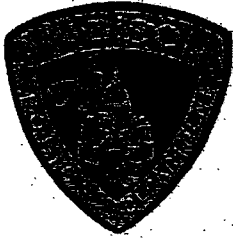
Ultimately, one suspect was positively linked to the armed robbery and arrested after he confessed and also gave up the name of his accomplice. A facsimile weapon was recovered as was a knife and other stolen property. The possible suspects in the vehicle were found to be wanted and also in possession of a significant quantity of drugs and cash. Both were arrested.

The investigation continues, but excellent police work got excellent results. Icy, snowy conditions and wind chills below zero did not deter these hard working officers from getting an extremely dangerous situation under control with arrests made and evidence recovered. Very nice work all around!

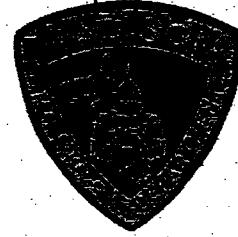

Synopsis:

(A note: I apologize for anyone that I missed in the above listing, and if I fail to give proper credit to many of the good decisions and ideas that individual officers provided. Disptach advised that 31 officers etc. were assigned to this call at one point or another).

On 7/3/07 at approximately 7:32 pm dispatch began sending officers to Mendota for an out of control situation that was updated to a riot in progress at Lorenz Hall, home of 29 violent juvenile offenders. Additional information was provided that two staff members were trapped in a room but not in immediate danger.

The incident, as we would later find out, occurred when an inmate was able to escape from control with a key and begin letting others out of their cells. At one point, the inmates had control of much of Lorenz Hall, but 11 'dead-enders' decided to hole up in a computer room, while the rest of the inmates returned to their cells. These individuals tore the room apart, made threats to Mendotal (and later MPD staff). Sgt Patterson, acting as the OIC, made an early and fortuitous decision to start sending downtown units to Mendota, which provided additional resources from the beginning of this incident.

While I was still enroute, Ryan Finnegan was able to advise that multiple juveniles were contained in a room at Lorenz Hall, that they had no hostages, and could not escape from the

room. Upon arrival I made contact with Mendota staff who advised that 11 offenders had barricaded themselves in the room, and improvised weapons from the furniture, computers, and large halogen light bulbs. They were requesting that MPD supplement their 20 or so employees in hard-gear. Officers Mike Brennan, Steve Chvala and others brought SET gear to Mendota, and within minutes of arrival there were approximately 10 officers in hard gear ready to go. Mendota staff wanted MPD's presence in hard gear, and the additional equipment and training that we have, to be used to bolster their presence and that the show of force might get compliance.

Given that no staff members were in danger, and that the juveniles were not fighting with one another, and that they had no opportunity to escape, the decision was made to slow things down and begin negotiation. Officer Donahue did an excellent job in negotiating with the juveniles, and progress was made on that end. While that negotiation was going on, contingency plans were being set in place should we need to enter the cell to extract or rescue. Ed Bernards brought the only chemical agents that could have been effectively deployed, and Matt Nordquist suggested then brought a less-lethal shotgun to further increase our options should negotiations fail. It was also clear (through subject verbalizations) that Henry Wilson and Ivan, who were staged nearby, had a very correcting influence on the rioters. Ultimately, we had a team in gasmasks and hard gear, and another team in hard gear available.

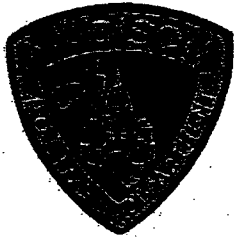
Beginning at approximately 8:13 pm, Mendota staff began pulling out cooperative subjects one at a time. This process continued until 8:34 p.m. when the last subject was placed into custody. MPD then did a secondary clear of the room. By 9:28pm, all of the subjects were accounted for, searched, and in their cells. All keys and other equipment were accounted for. No staff members or MPD personnel were injured. Several of the inmates suffered minor injuries at the hands of their cell-mates. One subject was ultimately arrested and taken to the PSB.

Although MPD personnel did not go 'hands-on' with any of the subjects, I believe our personnel provided the backup and assistance to Mendota staff that proved crucial to the outcome being so successful. I would like to take this opportunity to thank everyone who responded--and also to those that did not respond and were left to police the City near singlehandedly.

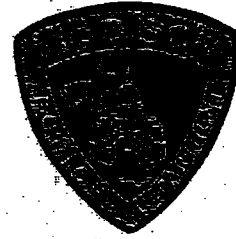

Synopsis:

On 07-15-07 on a beautiful Sunday afternoon, the alert tones sounded and virtually every officer in the East, North and South districts responded to a report of a man with a gun on the porch of ██████████ Camden Road threatening neighbors. The suspect, later identified as ██████████ was subsequently shot and killed as officers arrived on scene and ██████████ pointed the weapon in their direction. Within minutes, officers had worked together to take immediate emergency action and then to make sure the larger area was safe. The target address was tactically cleared, the scene was contained, witnesses were contacted and identified, evidence was secured, areas were canvassed, officers and citizens under duress were contacted and brought into less stressful environments and the in-depth investigation began to take form. Officers on scene did a phenomenal job of getting the work done. The Sergeants assisted at the scene (Samson), at UW ER (Krueger Favour) and in organizing assistance for the primary officers (R. Peterson.) The Investigators did an excellent job of organizing and processing the evidence. Lt. Jugovich, as OIC, made sure all the necessary resources were activated and made available. Detectives and

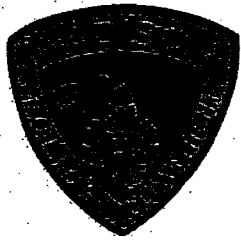
other command staff were located and came in from home to direct the investigation and set up a command post. Joel DeSpain also came in to deal with the media. Stenos (I'm sorry I do not know which ones) came in to work on reports. Assistant Chief Gaber and Chief Wray came in to offer assistance and contact officers.

I will not belabor the details. Suffice it to say that MPD is at it's best when we respond to these major cases. No one worries about anything trivial; everyone just pulls together to get the job done. Those I have listed here and all those I missed as they worked more quietly behind the scenes and in the days that followed deserve notice that their efforts were appreciated and exemplified the best in law enforcement.

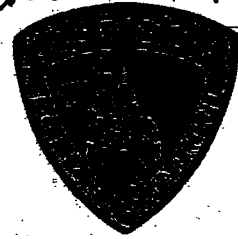

Synopsis:

Officers Chanda Dolsen and Matthew Kenny were dispatched to an out of control juvenile in the back seat of a Union cab. As Officer Dolsen approached the scene, her first clue that things would not go well was having her squad car pelted with rocks, cracking the side window, as she rolled up. As she got stopped and went out to take control of the 7 year old, her primary concern was trying to get him calmed down. He responded to this by punching her in the side of her head, injuring her. The suspect kept attacking, kicking and screaming and Chanda was forced to take the suspect to the ground. When he would not calm down, she finally had to handcuff him. She and Officer Kenny managed to get the kicking, screaming, threatening child into the squad car, but the suspect managed to bite Officer Dolsen's arm as she seat-belted him in. The transport to the station was like a scene from "The Exorcist." This child sang the most vile, repugnant rap music style threats, he made unbelievable comments about the officers, his teachers, the cab driver and even his own mother.

Once at the station, we placed the young suspect in a holding cell, still handcuffed. He continued to kick, scream and carry on, repeatedly kicking at the door and throwing himself around so that he presented a real threat to his own safety. At this point, I asked the officers to use a second set of handcuffs to attach the first set of cuffs to a metal restraining ring on the bench to control the suspects movements. As we tried to accomplish this, the juvenile continued to go berserk and managed to kick Officer Kenny in the groin, injuring him.

This disturbance was so extreme that everyone working in the building came out of their offices to see what was happening. Everyone was astounded at the suspect's age, his behaviors and the unbelievably vile things he kept spouting.

I offered to have both officers relieved so that they could take a minute and attend to their own injuries, but both officers assured me they were fine.

As the necessary phone calls were made and the investigation proceeded, the juvenile continued to be totally out of control. By this time it had been well over an hour that the officers were subject to these conditions. They again refused relief.

I stayed close and assisted when possible. Finally at some point, the holding cell room became more quiet and I went in, concerned that perhaps the boy was having a medical problem or had finally collapsed. Instead, I found the officers talking calmly and respectfully to the boy who was now, at least momentarily, acting more like a little boy. Officer Kenny assisted the boy in using the bathroom and getting washed up. Officer Dolsen talked him through the booking photo process. Officer Kenny talked him through the fingerprinting process, explaining everything as he went along, answering the little boys questions patiently. Both officers explained step-by-step what would be happening next and what their expectations were of the boy.

The remarkable thing about the scene I observed was that everyone else in the building who had been exposed to this toxicity was still angry and filled with disbelief over what this boy's behaviors had been like. The two officers who had been physically assaulted, injured and exposed more to his filthy language and threats were astoundingly calm and compassionate.

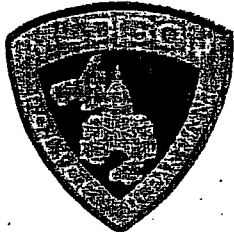

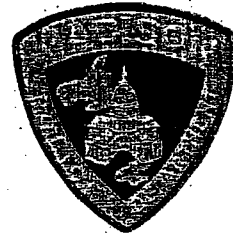

****Arrested Person - Recklessly Endangering Safety****

On 09-10-2006, at approximately 8:04pm, officers were dispatched to [redacted] Fordem Avenue for a report of a female hysterically screaming. Dispatch was unable to obtain much information due to the distraught state of the caller. Officers did learn that someone had been cut at this address prior to their arrival.

PO Lindsey was the first officer on scene and found a female victim in the front parking lot, [redacted] with a head injury, a male victim, [redacted] with a back injury and [redacted] covered in glass. [redacted] and [redacted] had been assaulted by [redacted] who had struck them with a baseball bat. The vehicle that they were operating had also been severely damaged by [redacted] with most of the windows broken out. [redacted] was in the vehicle at the time [redacted] struck it repeatedly with his bat. [redacted] the guardian for [redacted] was also present, as was the biological father, [redacted] Fox.

PO Lindsey relayed information immediately that [redacted] may be armed with a long rifle, after she learned that [redacted] had seen him with one after the assault. Officers quickly converged into the area and a perimeter was set around the building. [redacted] had allegedly seen [redacted] on his second floor balcony with a long rifle, but did not know if he was still in his apartment, [redacted]

Not knowing if [redacted] was wandering the interior of [redacted] Fordem (multi-unit apartment building), a clearing element was formed with a sergeant, officers and K-9. This clearing element began within the lower level parking garage and worked up to the second floor.

After the clear of the common areas had been completed, an order-out of apartments near [redacted] was started. While this was occurring, officers made contact with [redacted] mother on the exterior of the building and learned that [redacted] was within apartment 5. Almost immediately upon learning this, Officers R. Finnegan and Pharo made contact with [redacted] as he began to exit this first floor apartment. [redacted] was not compliant with verbal commands from the officers and attempted to flee back into apartment 5. PO R. Finnegan and PO Pharo were able to use active counter-measures and taser to arrest [redacted] who was found to be uninjured after he was secured.

[redacted] did provide consent to search his apartment (post-Miranda), but no weapon was located. There was ammunition recovered however. [redacted] did provide a statement and stated that his actions were in response to a perceived death threat that his roommate [redacted] received earlier, which he blamed [redacted] for. [redacted] was subsequently incarcerated.

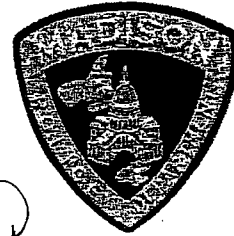

On 03-13-2005, Officer Gary and Officer Kenny responded to a report of a possible PNB individual at the Arby's restaurant, located at 4 Collins Court.

Upon arrival, Officer Gary and Officer Kenny found a 49-year-old white male from Rhinelander, Wisconsin who was suffering from cardiac arrest within his vehicle. Both officers immediately recognized the need to perform CPR. Officer Gary performed rescue breathing while Officer Kenny prepared his AED. An unidentified citizen assisted both officers by performing chest compressions.

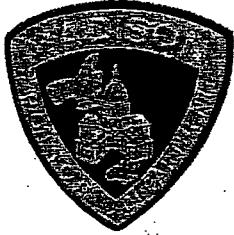
Officer Kenny properly delivered one shock to the patient using his AED, while Officer Gary and the unidentified citizen continued CPR for approximately two minutes prior to Fire Rescue arriving.

The patient was conveyed to an area hospital where he was eventually revived by medical staff. An attending physician commented to me that the rescue efforts by these two officers could have been the determining factor in the successful revival of this patient.

Both officers did an exceptional job and should be commended for their efforts.

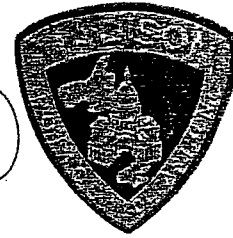

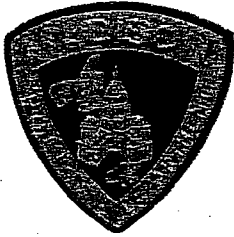
Officers followed footwear impressions in the snow to a nearby home where a perimeter was set up, residents were contacted and gave consent to search the premises.

On September 27, officers responded to the Clark Gas Station, at [redacted] South Park Street, for an armed robbery. The suspect was armed with a knife, and fled on foot after taking cash and cigarettes from the store. Officer Bill Brendel, who was the primary officer assigned to the incident, obtained a store security videotape showing the suspect. Officer Brendel and Detective Hammond then used the videotape to print three still photos displaying the suspect. Officer Boyd was able to obtain a possible name for the suspect from the photos: Louis Saffo.

On October 9, officers responded to the Open Pantry, at [redacted] West Beltline Highway, for an armed robbery. The suspect fit the physical description provided in the Clark Station robbery, and again the suspect had fled on foot after taking cash. Officer Kraig Knutson was the initial investigating officer, and Detective Alix Olson, who was assigned to follow-up on the case, subsequently presented the victim with a photo lineup (although the victim was unable to positively identify the suspect at that time).

On October 11, officers again responded to the Open Pantry, at [redacted] West Beltline Highway, for an armed robbery. The suspect—with a similar physical description to the previous robberies—had displayed a knife, and fled on foot after taking cash and cigarettes. Officer Jason Sweeney was the primary investigating officer, and Detective Matt Misener was assigned to follow-up on the case.

On October 14, officers responded to the Marathon Gas Station, at [redacted] Verona Road, for an armed robbery. Again, the suspect's description matched that provided in the earlier robberies, and the suspect had again displayed a knife and fled on foot after taking cash and cigarettes. Officer Erv Marks was the initial investigating officer and Detective Sara Petzold was assigned to

follow-up on the case.

Later on October 14, officers responded to the Mobil Gas Station, at [redacted] South Whitney Way, for an armed robbery. The suspect again displayed a knife and fled on foot after taking cash and cigarettes. Officer Denise Armstrong was the initial investigating officer, and Detective Sara Petzold was assigned to follow-up on the case.

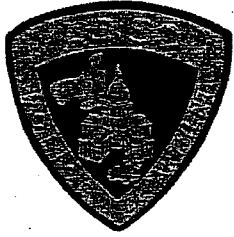
By that time, Detective Misener had put information in patrol briefing indicating that Louis Saffo was a suspect in the Clark Station robbery, and that Saffo was wanted for a probation violation. It also appeared that the Open Pantry, Marathon and Mobil robberies were related to the Clark Station robbery, given the similar suspect descriptions and behavior.

On October 15, at approximately 2:30am, West Patrol officers responded to the area of Allied Drive and Carling Drive for a report of a disturbance involving shots being fired. Dispatch provided a description of a vehicle that was possibly involved in the incident. Officer Streich observed the vehicle leaving the area as she pulled onto Allied Drive. She pulled behind the vehicle, and effected a high-risk traffic stop with the assistance of Officers Dave Samson, Dan Nale, Galen Wiering and Matt Kenney. The front passenger initially identified himself as Sammy Robinson, but Officer Streich compared him with a booking photo (that had been placed in briefing) of Louis Saffo and determined that the individual was, in fact, Louis Saffo. Saffo was arrested and incarcerated at that time.

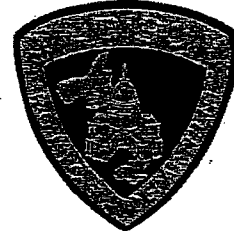
On October 17, Detectives Sara Petzold and Melanie Palmer responded to the PSB to interview Saffo about his involvement in the series of robberies that had occurred between September 27 and October 14. Saffo subsequently provided a full confession, implicating himself in all five robberies.

I feel that these cases reflect an excellent example of professionalism and dedication on the part of all involved. The initial responding officers obtained suspect descriptions demonstrating the linkage between these robberies, and in some cases were able to obtain surveillance photos that eventually led to Saffo's arrest. Officer Boyd was able to connect a name with the initial photos obtained from the Clark Station robbery, and the availability of this information to patrol officers was critical to the successful resolution of this series of robberies. Officer Streich's observation of Saffo's vehicle and recognition of him from briefing materials resulted in his arrest, and the assistance of other patrol personnel during the high-risk traffic stop ensured that Saffo was taken into custody in a safe manner. Finally, Detectives Petzold and Palmer were able to obtain confessions from Saffo—definitively tying him to all five robberies. The successful resolution of these cases demonstrates a high level of skill, communication, awareness, and commitment. The end result of this collective effort is the clearing of five armed robberies, and the removal of a potentially violent individual from the community. All personnel involved in these cases performed in an exemplary manner, and I feel that they should be commended for their efforts.

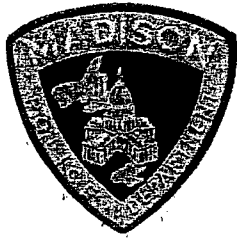

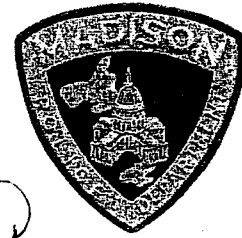

On 03-13-2005, Officer Gary and Officer Kenny responded to a report of a possible PNB individual at the Arby's restaurant, located at 4 Collins Court.

Upon arrival, Officer Gary and Officer Kenny found a 49-year-old white male from Rhinelander, Wisconsin who was suffering from cardiac arrest within his vehicle. Both officers immediately recognized the need to perform CPR. Officer Gary performed rescue breathing while Officer Kenny prepared his AED. An unidentified citizen assisted both officers by performing chest compressions.

Officer Kenny properly delivered one shock to the patient using his AED, while Officer Gary and the unidentified citizen continued CPR for approximately two minutes prior to Fire Rescue arriving.

The patient was conveyed to an area hospital where he was eventually revived by medical staff. An attending physician commented to me that the rescue efforts by these two officers could have been the determining factor in the successful revival of this patient.

Both officers did an exceptional job and should be commended for their efforts.




