OFFICER NARRATIVE

On 03/08/15, at 8:18 PM, I was assigned a phone message reference threats on facebook.

I made phone contact with the victim, who ID'd herself verbally to me as [REDACTED] who said she was threatened on facebook. She said she was on facebook and gave her opinion on the officer involved shooting on Williamson St. and someone didn't like what she had to say. She said the suspect, who goes by [REDACTED] wrote:

"THIS BITCH RIGHT HERE THO TF BITCH [REDACTED] YOU MAKE NO SENSE LET IT HAD BEEN. YO CHILD?? YOU SAYING HUMANS CANT MAKE MISTAKES AND LEARN FROM THEM?? YOU DON'T KNOW SHIT MFKA NEED TO SHOOT YOU 5 TIMES IN THE FACE!! FUCK MPD!! [REDACTED] HE AIN'T HAVE TO DIE."

[REDACTED] said she took this as a threat and that she's scared and wanted it documented. She said she unfollowed [REDACTED] but her other friends on facebook told her that [REDACTED] and others know who she is and she's afraid they might go to her work place and do something to her. She said she doesn't know who [REDACTED] is.

[REDACTED] emailed me the conversations.

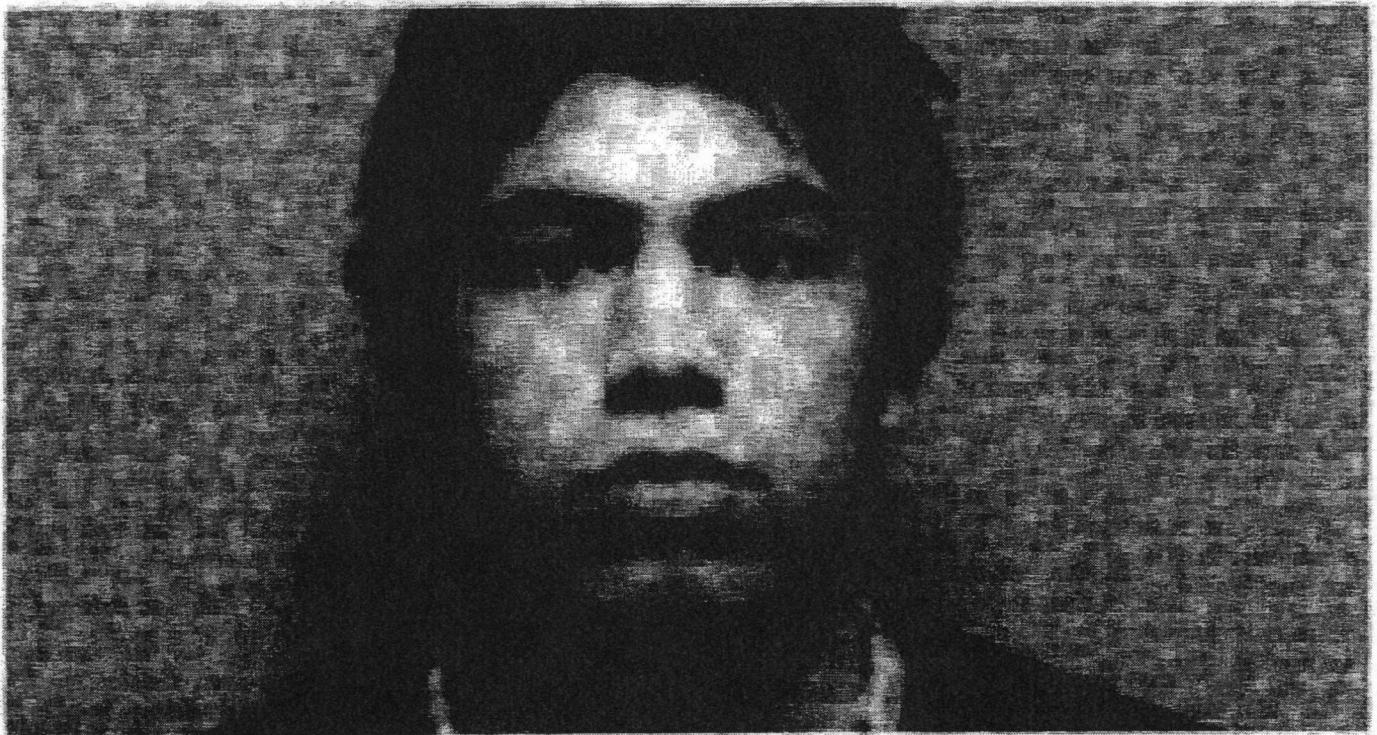

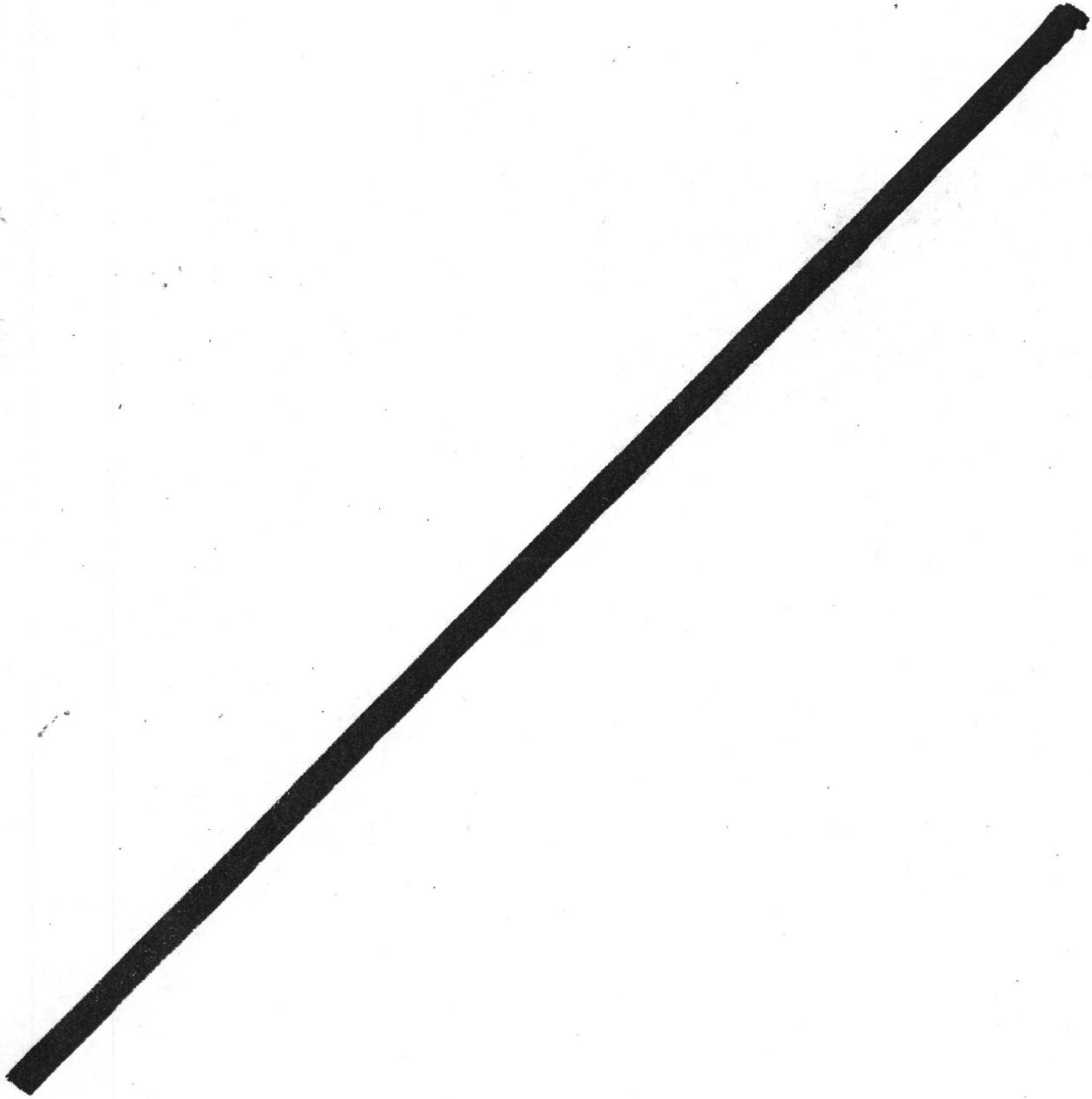

On March 7, 2015, I was assigned to guard the scene on Williamson Street. Assigned with me were several other officers as well as command staff.

At one point, the person leading the crowd in chants was talking through a bullhorn. It was very loud and chaotic.

I was standing near the driveway, close to the house, behind the crime scene tape. The person using the bullhorn stopped speaking for a few moments. At this time, individual crowd participants took this opportunity to hurl their own style of comments towards us.

People were pushed up very close to the crime scene tape. I heard such comments as "you should be ashamed of yourselves"; "take your badge off. Let's fight right now. Don't you go grocery shopping?"; and "wait until Anonymous gets ahold of you."

Each of the comments was of concern to me; however, the comment about Anonymous did cause me to look in that direction. While I couldn't be sure who actually said the comment, I looked to that area and noted a f/w, about 20 years old, dressed in brown. I do not know if I could ID this person if I were to see her again.

The reason I paid her comment special attention, is because I am aware there is a person/organization who calls themselves Anonymous and chooses the Internet to victimize others.

I did not initially do a report on hearing this. Upon hearing the City of Madison Website may have been targeted, I decided to complete a supplemental report. Please see other reports for further information. NFA/Slh2

OFFICER NARRATIVE

On 3/13/2015, I was working as an officer in the Criminal Intelligence Section when I was notified by Captain Wheeler about a concerning Facebook post by [REDACTED]. The posts were made by the Facebook account named [REDACTED] with the URL of [REDACTED]. Screen shots were provided to me of this post.

The post was as follows: "Look people need to kill cops now or it won't stop."

I looked at the Facebook page and recognized the identified [REDACTED] in the pages photo's as [REDACTED] M/B [REDACTED]. I also noted that the above post was no longer on this page. I also knew that [REDACTED] was just recently notified by our Special Investigations Unit (SIU) for focused deterrence.

I saw that [REDACTED] made some other statements on his page relating to violence against police which caused me concern, however no specific threat. One of the statements he made was:

"Let's get one thing straight when i expres my anger in saying we need to kill cops in order for a solution in my view yes sime cops do need to die . just as much alot of people don't need to be on this planet. We're at war our people are being murdered every day being imprisoned living in stagnant conditions and if a nigga got a problem with what i post and you don't think about the gravity of our situation as a hole and you act like you have knoe feeling to the matters at hand yousound like a boot licking uncle tom. Go kill yourself mark." Posted on 3/13/2015 at 7:25am.

I spoke with Captain Wheeler and Lieutenant Patterson and decided that I should try to contact Hanaway and talk to him about the statements. PO Patricia Drury and I attempted contact at his residence in Monona. Based on [REDACTED] violent history, we did ask for a uniformed Monona officer to assist us in our attempt to contact. PO Drury and I were in plain clothes.

We were told by [REDACTED] mother that he was not home.

I was able to reach [REDACTED] by phone on 3/13/2015 at approximately 3:15pm. I explained to him that I was aware that he made some statements on Facebook, which law enforcement perceived as threatening. [REDACTED] told me that he was just angry and frustrated about current issues involving police and use of force and said he was just venting this on Facebook. He admitted to writing the posts and said that he has since "retracted" his statements. He assured me that he had no intent to harm police or anybody else. I told him that we all want him to succeed and that there are many resources available to him and that he can contact SIU if he needs information.

I am also aware from past reports that [REDACTED] has issues related to alcohol. He did seem

sober at the time I spoke with him on the phone.

OFFICER NARRATIVE

On 03/13/15, I was working as a police officer assigned to the Criminal Intelligence Section and the Violent Crime Unit. I was notified by Capt. Wheeler about a Facebook post from an individual later identified by PO Amy Bramlett as [REDACTED], a recently notified SIU offender. In regard to the Facebook post, Capt. Wheeler stated that [REDACTED] made comments about causing harm to police officers and considering current events, he was not the only threat to law enforcement that had come through. PO Bramlett's original report covers several of the statements that she had noticed on [REDACTED] Facebook site. Three other comments on the exact same site that occurred earlier which were not covered would be the first one on 03/06/15, at 11:05 p.m., "we should kill cops. It seems like it's the best alternative". Next comment on 03/06/15, at 11:34 p.m., "in order for real peace. War is the only remedy". Next comment on 03/07/15, at 12:28 a.m., "we need to march on the police departments and block them from going out on patrol".

Those were the only other quotes that I had noticed on [REDACTED] Facebook site that had not been covered in PO Bramlett's original report.

Dear County Executive Joe Parisi~

On Friday night, I'm sure you are aware that the Madison Police Department had an officer involved shooting. Within hours of this incident, many spontaneous and planned protest events began in the downtown area. This letter is not intended to go into the details of that event specifically, but to bring to your attention the very disturbing behavior of one of the Dane County Supervisors.

In the early morning hours of Saturday, March 7, protestors had gathered at the site of the incident in the 1100 block of Williamson Street, and at best their tone can only be described as angry and volatile. At least one Madison Police squad car was damaged during the spontaneous gathering, and the situation was extremely tense. Our officers acted with the appropriate decorum and restraint during these moments, and followed citizen protestors throughout the weekend with a goal of keeping the crime scene, the citizens, and all property safe.

However, around midnight, a group of about 100 protestors moved from the Williamson Street area up to the City-County Building (CCB). These citizens were very angry and were trying to gain access to the building and the police department. Comments such as "kill the cops" and "we have guns too" were yelled frequently. Again, my officers acted with the utmost professionalism and watched over these citizens to ensure their safety, and the safety of all the employees working in this building. We felt comfortable knowing that the City-County Building was locked and closed. We had stationed officers at all the entrances so that people on official business, with a need to enter the building, could do so. However, due to safety concerns, officers were instructed not to allow any protestors entry to the building.

At approximately 12:30am, County Supervisor Leland Pan drove up to the CCB garage doors. He identified himself as a County Supervisor and indicated he had official business within the building. There were three occupants in his car. The officers appropriately allowed him to enter the building, and did not question who was with him in the car. He is a leader of this community and there should be no reason for our officers to question his motives or his need for access to the building. Minutes later, County Supervisor Pan was seen facilitating the opening of doors that allowed hostile protestors into the CCB. He was then seen facilitating the use of the CCB elevators to allow these protestors access to multiple floors of the building. The result of this County Supervisor's irresponsible behavior resulted in the need to pull additional resources to the CCB to keep order. Our resources were stretched extremely thin, yet the protestors grew in numbers and their anger increased as they neared the police department. I'm sure you are well aware that, in addition to commissioned officers working in this building 24 hours a day, there are civilian employees. Quite frankly, these civilian employees were very scared for their safety.

Let me be clear, County Supervisor Pan's actions put everyone's safety at risk - the protestors, police officers and every employee working in the building. This is inexcusable.

As soon as I learned what happened, I telephone Supervisor Pan and told him to come back to the building and turn in his keys and wallet pass card. He attempted to scrape off his vehicle sticker, but I am told he was unable to do so. One of my Assistant Chiefs have made a request to Facilities Management to have both these access cards disabled. I do not believe he should be given his keys or access cards back during these tense times. He has proven to have poor decision-making skills. His keys and pass card were collected and property tagged. A case number was generated and I have directed staff to review this case to determine if any charges are warranted. I wanted to give you this information as a courtesy and to leave it to you to determine what should happen with this property that I believe belongs to Dane County.

Obviously, I am very frustrated that the behavior of a trusted public figure would put so many people's safety at risk. I do not know what can be done from your office, but the City of Madison Police Department has taken his behavior seriously and will determine what next steps should be taken.

OFFICER NARRATIVE

On 03/07/2015, I was assigned to D42 as the Langdon Neighborhood Officer. On 03/06/2015, I had been assisting with an officer involved shooting call that had taken place at 1125 Williamson St under case 15-71913. I was assigned security for the CCB basement garage with Officer Dan Hamilton. Officer Hamilton and I were checking vehicles as they entered the CCB basement in order to control the flow of people into the basement and to ensure that they belong to the building.

Sometime around midnight on 03/07/2015, I observed a silver Honda pull up to the exterior garage door from the W Wilson St side of the City County Building. Officer Hamilton did make contact with the Asian male driver who identified himself with his Wisconsin photo driver's license as Leland Pan. Pan had advised Officer Hamilton that he was a District Five supervisor for the Dane County board, so we then allowed him entry into the basement. I also observed he had two female passengers with him in the vehicle.

I then observed Pan park his silver Honda Accord in the first row of parking stalls inside the garage door. I observed the vehicle had Wisconsin plate 766CHT. Attached to the report is a photograph of this vehicle parked in the basement.

I then continued assisting with the City County Building security, and Officer Hamilton and I patrolled the exterior of the building as well. At approximately 12:36am, on 03/07/2015, I heard Sgt Alex Berkovitz advise over the radio that people were now entering the Martin Luther King Jr Blvd entrance to the City County Building even though the doors had been locked and secured for the evening. I was aware that the building was closed for the evening and that these subjects were now trespassing.

I then responded to the first floor of the City County Building on the MLK Jr side where I observed a steady flow of people entering the building. I had been advised that these were the same protesters who had been on Williamson St earlier in the evening.

I estimated the crowd to be around 100 individuals, and as they continued to enter the building, they then descended the stairs to the ground level of the City County Building. I attempted to advise these subjects that there was a gate on the ground level that would prevent them from moving about the building, and I then observed the group congregate on the ground floor as the gate was secured on the ground floor.

I then remained in the area and continued to monitor the subjects to prevent them from entering deeper into the City County Building. While standing by the main elevators on the MLK side of the CCB, I observed that the elevator was in use. I was aware though that the elevator had been locked down for the evening, and it required a key to operate it. As the elevator door opened, I observed this same Asian male that had been driving the Honda Civic, and he was controlling the elevator with keys. A group of individuals then exited the elevator onto the first floor as the majority of the crowd began to reappear on the first floor from the ground level.

The elevator then closed, and shortly after this, another load of people were brought up on the elevator and let out on the first floor. I again saw the Asian male operating the elevator, and I then asked him to step out at that time as I believed he was operating the elevator and allowing the travel between the floors.

I then spoke with this individual off to the side as the crowd on the first floor began to grow in numbers. I asked him if I could see his identification. He first handed me a driver's license belonging to a Joseph Gangler, but he stated that this was not his, and somebody had turned in to him after they found it. He later turned this ID over to me.

I then identified this subject with this Wisconsin photo driver's license as Leland Pan, and I confirmed that he was the same subject who had been driving the Honda Civic we had let in the garage door earlier. I asked Pan if he was operating the elevator to allow passenger between the floor, and he stated that he was. I was then aware that he did have keys to access the building and elevators, but I did not see him using any at that time.

I then asked Pan if he was responsible for letting the people into the building on the locked MLK side of the building, but he was vague in his responses. He stated that he had directed the people to this entrance, but he did not admit at that time to opening the doors.

At this time, numerous other protestors who were in the area observed that I was speaking to Pan and approximately 20 individuals then walked over and stood directly next to us. I then observed a subject with a video camera and bright light videotaping our encounter.

I then returned Pan's ID to him, and I ended my contact with him at that time.

After clearing from the area, I then searched for Leland Pan's information on the Dane County website and observed that he was indeed a Dane County Board Supervisor for District Five in Dane County. A copy of his profile from this website is attached to this report.

I then viewed video from the CCB lobby from the city camera network system. Attached to this report are five screen shot photos from the city.

The first video from the "CCB Lobby Left" camera at 12:34am shows the subject identified as Pan walking from the elevator bank area toward the front doors. A larger white male with a

longer white goatee was following shortly behind him, and I observed the other two females who were originally in the vehicle with him were behind him as well.

The next photo shows the back of Pan's head as he approached the center bank of doors, and this is captured on the "CCB Lobby Center" camera at 12:34am. The next photo shows Pan walking away from the front doors after he had opened the doors to allow the massive crowd in. This was captured on the "CCB Lobby Center" camera at 12:34am.

The next photo from the "CCB Lobby Center" camera shows individuals begin to enter the building from the MLK entrance doors, and it shows a photo of Pan watching them as they began to enter.

The final photo from the "CCB Lobby Left" camera at 12:35am shows Pan standing in the middle of approximately 15 individuals who now began to fill the lobby. As noted earlier, I estimated upwards of 100 people that had eventually entered the building after the doors had been opened by Pan.

The crowd then remained in the building for approximately the next hour before eventually dispersing on their own. After contacting the central district command staff, I was advised that Chief Koval had made contact with Pan by phone and asked him to return to the City County Building to contact me.

Officer Hamilton and I then made contact with Pan when he returned to the Carroll St entrance of the CCB at around 2am. I then verbally identified Pan again at that time. I observed Pan was still wearing the same green coat as he was wearing in the attached photos.

Pan then turned over to me his City County Building metal key that accessed the exterior doors as well as his electronic key pass. The electronic key had the numbers "11754581-18 06029" stamped on it, and the metal key had "83 313" stamped on it. I later placed these items into the CCB property room as evidence under tag 340505. Pan also volunteered to me that he did have a bar code sticker on his vehicle that allowed him access to the CCB basement garage. He later attempted to scrape this sticker off his car, and after attempting to remove it for about ten minutes, he was unable to fully remove it due to it not coming off easily. I had later advised Pan that he was no longer allowed to use this pass to enter the City County Building until advised further.

I again asked Pan what happened tonight and asked him to explain to me how he was involved in letting the subjects inside the building. I asked him what he was doing at the City County Building at this time of night when we originally let him in the garage doors, and he stated that he was meeting with some constituents to discuss the aftermath of the shooting.

I asked Leland if he had then used his keys to exit the locked MLK lobby of the building, and he admitted that he did. I asked Pan if he had then opened the door for the protestors to enter, and he provided a vague answer that he had guided others to this area. I then showed Pan the screenshots of the photos I had taken from our surveillance system, and I pointed out that he was in the photos at the time the people entered. Pan then admitted that he had opened the door to allow the protestors in. I asked Pan who the large white male behind him with the white goatee was, and he stated that he was told he was a family member of somebody involved in the incident and that he had just met him.

Before ending my contact with Pan, I advised him that I did not know what the outcome of this investigation would be but that he, in the meantime, would not be allowed into the City County Building without supervision. We then ended our contact at that time.

Also on 03/07/2015, I sent an e-mail to the Madison Police Forensics Unit and requested that they save this video as evidence.

OFFICER NARRATIVE

OFFICER INFORMATION AND ASSIGNMENT

On 03/06/2015, I was assigned as 1343 to the Central District Community Policing Team in the city of Madison. I was dressed in full military style Madison Police Department uniform and assigned to roaming exterior security at the City County Building.

CONTACT PAN

PO S. Kelly and I were partnered and relieving PO J. Bower from his assignment in the City County Building basement. While verifying authorized personnel were entering the basement, I saw a light colored four door vehicle approach the basement parking ramp. The time was approximately midnight, but I did not document its specific arrival. The vehicle was occupied by two females and one male driver. The driver was later identified as **Leland T. Pan**. I approached the driver's side door, and Pan lowered his window. Pan and both passengers were dressed in casual attire, and I did not see any recognizable identification associating them to the building.

I asked Pan who he was associated with. Pan provided me his Wisconsin photo driver's license and stated he is the Representative for District 5 on the County Board. I noted both passengers avoided eye contact with me, but as Pan is employed in the building, he was permitted to enter.

ADDITIONAL INFORMATION

Shortly after Pan's arrival, I was notified of unauthorized personnel entering the City County Building from the Martin Luther King Jr. Boulevard entrance. I entered the main lobby to see an older white male holding open the security locked exterior door. I recognized the male, as previously he had been given limited access to the Wilson Street lobby. I estimated seventy to eighty subjects entered the lobby, and they began to filter out into nearby stairwells and elevators.

PO K. Parks, PO T. Liston, and three unidentified Wisconsin Capitol Police Officers assisted me in securing the doors. We maintained security on the interior doorway and were joined by additional patrol officers. See PO Kelly's original report for additional details.
