Members of the Common Council have been invited to attend the meeting being held by Downtown Madison Inc. to discuss issues on State Street on Thursday, January 5, 2017 at 3:00 p.m. in Room 201 of the City-County Building, 210 Martin Luther King, Jr. Boulevard. A possible quorum of the Council may exist at this meeting.

Meeting with Alders Upper State Street Area

January 5, 2017

3-5pm 201 CCB

A group of Alders (lead by those who were at the original November 2nd meeting) will begin the meeting (on the Upper State Street Area) with police and city attorney's office to access the strategies that are currently in place (including how much they cost) and decide if they are making a difference and need to be continued (this is in connection with the negative behaviors occurring regularly in this area). The Alders heard from the Property and Business owners in the 100 block of State Street and Capitol Square (on November 2nd) about the constant negative behaviors including intoxication, public urination & defecation and drug sales & use on a daily basis and sometimes in their place of business.

- I. The group will discuss/set new strategies including looking into the upper State Street area becoming a city park and possible varying shift changes for police (including other ideas to move the bad behavior out of the area)
- II. Address the alley challenges (behind 30 on the Square) and work with the property owners to find a long-term solution.
- III. Discuss the Council "revisiting" the proposed ordinance on prohibiting sleeping/laying down on sidewalk during the day in the BID.
- IV. Talk with Dane County Supervisors about involvement from Dane County Health and Human Services (Supervisor Kolar will be in attendance).
- V. Moving forward, discuss/think about engaging the area with pop-up businesses or other similar ideas that Jeff Haupt shared with the group on November 2nd. Knowing that the programs from BID have been positive, but something is needed on a daily basis to make better use of this valuable/visible space.
- VI. Additional ideas/thoughts for engaging this area and eliminating the bad/negative behaviors.
- VII. Confirm next steps
