Summary of changes to CoC Con

Information for Bonus points, from p. 84-86 of the NOFO

Leveraging Housing Resources: CoCs will receive full points by demonstrating that they have applied for at least one PSH or RRH project that utilizes housing subsidies or subsidized housing units not funded through the CoC or ESG programs. The CoC must demonstrate that these housing units will:

-in the case of PSH, provide at least 25% of the units included in the project

-in the case of RRH, serve at least 25% of the program participants anticipated to be served by the project Housing leverage can come from the following sources: private organizations, state or local government (including through the use of HOME funding provided through the American Rescue Plan), Public Housing Agencies (including through the use of a set aside or limited preference), faith-based organizations or federal programs other than the CoC or ESG programs.

Leveraging Healthcare Resources: CoCs must demonstrate through a written commitment form a healthcare organizations that:

-in the case of a substance abuse treatment or recovery provider, it will provide access to treatment or recovery services for all program participants who qualify an choose those services; or

-the value of assistance being provides is at least an amount that is equivalent to 25% of the funding being requested for the project, which will be covered by the healthcare organization.

Sources of healthcare resources include: direct contributions from a public or private health insurance provider to the project (e.g. Medicaid) and provision of health care services by a private or public organization (e.g., Ryan White funded organization) tailored to the program participants of the projects.



## What is EHH funding?

- Combination of the following grant sources:
  - Federal Emergency Solutions Grant (ESG) that comes to State of Wisconsin
  - State Homeless Prevention Program (HPP) grant
  - State Housing Assistance Program (HAP) grant
- State allocates EHH funds to Continuum of Cares (CoCs); each CoC submits a consolidated application to the State
- City of Madison has served as the lead applicant and grant recipient for Dane CoC and subcontracts with agencies approved by the Dane CoC Board of Directors
- 2023-24 EHH New Grant Period: July 1, 2023 September 30, 2024

2022 Funding Analysis

# #1: Approve the City of Madison as the lead agency for & receipient of the 2023-24 EHH grant for Dane CoC

- City of Madison will complete the consolidated application and submit to the State and serve as the recipient of the grant.
- City of Madison will subcontract with agencies and projects approved by the Dane CoC board, process invoices, conduct monitoring and provide other EHH required administrative activities.
- City of Madison will take the max allowable ESG administrative funds, 3% of the ESG funds or \$9,782. City of Madison will not take HPP or HAP administrative funds.

### 2023-24 State EHH Allocation Procedure

The following EHH allocation policy was approved prior to the last year's EHH competition:

- EHH competition will be conducted every other year in Dane CoC.
- In an off-competition year, if the funding level from the State goes up by more than 5% of the total grant amount, then new or expansion project applications will be solicited for the increased amount. If the funding level goes down, or increases by 5% or less, then the difference will be prorated to existing programs based on the current funding amounts.
