EMERGENCY ORDER #4

WHEREAS, on May 30, 2020, I issued an emergency proclamation that an emergency exists within the City of Madison resulting from civil commotion, disturbances, looting and rioting, and

WHEREAS, this civil commotion, looting, and rioting within the City of Madison presents an imminent threat of disaster which may impact transportation, fire, police protection and other critical response systems within the City of Madison, and

WHEREAS, on May 31, 2020, there continued to be civil commotion, disturbances, looting and rioting; and


WHEREAS, based on the incidents of civil commotion, disturbances, looting and rioting there continues to be the need to impose the restrictions outlined below.

NOW, THEREFORE, I HEREBY ORDER THE FOLLOWING:

1. A curfew is hereby imposed at the following times:
 - a. June 1, 2020, at 9:30 p.m. until June 2, 2020, at 5:00 a.m.
 - b. June 2, 2020, at 9:30 p.m. until June 3, 2020, at 5:00 a.m.
2. The above mentioned curfew is in effect for the following locations:
 - a. 600 N. Park St. south to 900 S. Park St., 1200 W. Lakeside St. east to 300 E. Lakeside St., to Lake Monona shoreline east to the Yahara River; Yahara River north to Lake Mendota, Lake Mendota shoreline west to 600 N. Park St.
3. Vehicular and pedestrian traffic is hereby prohibited during the times mentioned in Section a. above and in the locations mentioned in Section b. above.
4. The above mentioned sections do not apply to the following:
 - a. Individuals traveling to their residence.
 - b. Government employees.
 - c. Social services employees.
 - d. Credentialed press acting in their official capacity.
 - e. Individuals traveling to hospitals, clinics and medical facilities
5. All businesses in the following locations are closed on June 1, 2020, at 9:30 p.m. until June 2, 2020, at 5:00 a.m. and June 2, 2020, at 9:30 p.m. until June 3, 2020, at 5:00 a.m.:
 - a. 100-800 blocks of State St.
 - b. 500-800 blocks of University Ave.
 - c. 200-400 blocks of W. Gorham St.
 - d. 200-400 blocks of W. Gilman St.
 - e. 300-500 blocks of N. Frances St.

- f. 300-500 blocks of Lake St.
- g. 400 block East Campus Mall
- h. 200-300 blocks N. Henry St.
- i. 100 block of Fairchild St.
- j. 200 block of W. Dayton St.
- k. 100 block of W. Mifflin St.
- l. 100-200 blocks of N. Carroll St.
