Items Requiring a Fee

On the reverse side of this sheet, you will see a chart that shows the items requiring a fee and their cost. If the item is not listed, then it likely does not require a fee.

Resource Recovery Special Charge (RRSC) & Fees

If your home pays the Resource Recovery Special Charge, you will not be charged additional fees for the items listed on the reverse side of this sheet when you schedule a curbside collection or when you bring these items to a drop-off site.

Starting in 2024, RRSC funds cover the costs associated with the processing and handling of these large items that carry a cost.

Who Pays the RRSC?

If your home receives recycling collection from the City of Madison Streets Division at the curb, then you pay the RRSC. This monthly charge appears on your Municipal Services bill, which many people refer to as the water bill.

People Who Do Not Pay the RRSC

If your home does not pay the Resource Recovery Special Charge, you need to pay the necessary fees when you schedule the large item work orders for curbside collection or before you bring an item to the drop-off site.

The people who do not pay the RRSC are residents of larger buildings that have dumpster collection from a private company for their recycling. This also includes residents who live on private drives and carriage lanes that also receive collection from a private service.

- » Sites are for City of Madison residents and taxpayers only.
- » Proof of residency or taxpayer status is required.
- » Contractors may not use the drop-off sites.
- » You are allowed 1 trip a day.
- » The single load must not exceed what would fit into a standard pick-up truck bed or a 5' x 8' trailer.
