PUBLIC NOTICE TO ALL CUSTOMERS OF MADISON WATER UTILITY

Madison Water Utility has filed an application with the Public Service Commission of Wisconsin (PSCW) to increase water rates. The increase is necessary due to a 5.8 percent increase in gross plant investment and a 3.2 percent increase in operating expenses since the last water rate case was completed in 2020.

The total increase in water revenues requested is \$8,498,655 which will result in an estimated overall rate increase of 18.12 percent over the water utility's present revenues. If the request is granted, the water charge for an average residential customer with a ⁵/₈-inch or ³/₄-inch meter who uses 4,000 gallons of water per month will increase from \$29.92 to \$34.92, or 16.71%. This increase **only** applies to the Water charges on your bill. Charges for Sewer, Storm Water, Landfill, Resource Recovery, and Urban Forestry are not a part of this rate application.

An audiovisual public hearing on the application has been scheduled for Wednesday, September 7, 2022 at 10:00 a.m. This virtual hearing has no physical location. This is a virtual hearing to which members of the public may attend by audiovisual connection over the internet, telephone or listen to live broadcast on-line.
