**NORTH SHERMAN AVENUE WELL:** An Iron and Manganese filter is being planned for the well located on N. Sherman Avenue just north of Shabazz High School. The well, designated as Well 7 & constructed in 1939, is in poor of upgrade and water quality distates that a filter.

in need of upgrade and water quality dictates that a filter be constructed to remove iron and manganese *Next Steps:* Currently construction is planned for 2014.

*Service Area:* Generally from Schlimgen to Tenny Park, Maple Bluff on the west and Packers Avenue on the East.

OLBRICH PARK WELL: An Iron and Manganese filter is being planned for the well located at the west end of Olbrich Park. The well, designated as Well 8 & constructed in 1945, will be upgraded and water quality dictates that a filter be constructed to remove iron and manganese. Next Steps: Currently construction is planned for 2013.

*Service Area:* Generally the area south of E. Washington from Olbrich Park east to the Yahara River.

**EAST SIDE WELL REPLACEMENT:** Well #3, located at E. Johnson and 1st, was abandoned in 2008. A comprehensive review of the long term drinking water supply needs of the east side indicated the well needs to be replaced. A search for a suitable site is ongoing and has identified several potential well sites.

Next Steps: Currently construction is planned for 2017

*Service Area:* Generally east of the Yahara River to Stoughton Rd and Olbrich Park to Sycamore.
